### Zenviron secures Murra Warra Stage II Wind Farm contract

Zenviron Pty Ltd ("Zenviron"), full service balance of plant specialists has been awarded a contract with General Electric International Inc ("GEI"), a global leader in wind energy solutions, for the delivery of the Murra Warra Stage II Wind Farm in regional Victoria.

It is expected that Zenviron will perform approximately \$80 million of works under the contract, delivering balance of plant civil and electrical works.

Speaking on the contract award, Zenviron General Manager Carl Keating said this marked further work with General Electric, highlighting the strength in its relationships and demonstrated capability to deliver.

"Zenviron continues to grow with Australia's renewable energy market. Murra Warra Stage II Wind Farm is our ninth contract award, demonstrating our leadership in the renewable market delivering balance of plant works," said Mr Keating.

The Murra Warra Stage II Wind Farm project is the second stage of a development by RES Australia Pty Ltd and Macquarie Capital.

The 209MW wind farm located 25km north of Horsham, Victoria will consist of a total 38 turbines. It will produce enough clean energy to power 150,000 homes and reduce carbon emissions by approximately 500,000 tonnes each year.

Works will commence from July 2020, with completion expected in March 2022.

The wind farm will offer up to 200 jobs during the construction period, and provide financial support to the local community through a community benefits program.
