The terms and conditions of the Options are as follows:

- (a) **Right to acquire Share:** Each Option will confer on the holder the right to acquire, upon exercise of the Option, one (1) Share in the Company.
- (b) **Vesting and Expiry Dates:** The Options will vest immediately upon the applicable service hurdle, being completion of 12 months service from 1 October 2020 (**Vesting Conditions**), being satisfied (**Vesting Date**) and (subject to paragraphs (c) and (e) below) expire on the expiry date (**Expiry Date**). Immediately after the Expiry Date, the Options and all rights attaching to them will automatically terminate.

- B. the date that a takeover bid (which is recommended for acceptance by the Board) becomes unconditional.
