A share price premium to NTA

We are confident that we can achieve the Premium Target and are pleased to provide shareholders with certainty if it is not met.

We are committed to and aligned with ensuring the success of WAM Alternative Assets. I have recently increased my holding in the Company and currently hold 7.4 million shares, representing over 3.8% of the Company.
