IBX Secures Additional Capital - Shareholders Exercise Options

MELBOURNE — Imagination Biosystems Limited (ASX: IBX) (the **Company** or **Imagination**) announces that it has received a total of \$143,157 for the exercise of Options.

Comprised of \$142,200 for 2,370,000 Options exercisable at 6 cents and expiring on 27 November 2020 and \$957 for the exercise of 31,900 Listed Options exercisable at 3 cents and expiring on 28 April 2023.
