## IBX Secures Additional Capital - Shareholders Exercise Options

**MELBOURNE** — Imagination Biosystems Limited (ASX: IBX) (the **Company** or **Imagination**) announces that it has received a total of \$143,157 for the exercise of Options.

Comprised of \$142,200 for 2,370,000 Options exercisable at 6 cents and expiring on 27 November 2020 and \$957 for the exercise of 31,900 Listed Options exercisable at 3 cents and expiring on 28 April 2023.

The exercise of these options has resulted in the issue of 2,401,900 fully paid ordinary shares, as outlined in the attached application for quotation (Appendix 2A).
