Canniberia \$1.9M Technology Purchase Order Clarification

Further to the announcement lodged by Roto-Gro International Limited ("ASX:RGI", "RotoGro" or the "Company"), with the ASX on Tuesday, 20 October 2020 regarding the CAD 1.9M (equivalent to AUD 2.03M) Purchase and Sale Agreement (the "Agreement") executed between the Company's wholly owned subsidiary Roto-Gro World Wide (Canada) Inc. ("RGWW") and Canniberia LDA ("Canniberia"), the Company would like to provide the following additional information in respect of the Agreement.

Pre-Licence Approval

Canniberia has advised the Company that its application for a pre-approval licence for a lawful cannabis cultivation licence (the "**Pre-Licence**") is in the final stages of completion and is expected to be submitted to Infarmed, I.P. ("**Infarmed**") by 31 October 2020. The grant of the Pre-Licence is a condition precedent to the Agreement. The following items must be provided by Canniberia to Infarmed to complete the application for the Pre-License:

- an identification of the likely stages of development of the Canniberia cultivation facility (the "Facility"), including forecasts of dates, the source of required products and the location of the Facility;
- 2. an estimation of the likely quantity of each variety of plant to be cultivated at the Facility, along with an estimation of the likely quantity of product to be produced at the Facility, the application of the product(s) and the expected destination of the product(s);
- 3. a description of the techniques used in each stage of cultivation at the Facility;
- 4. a detailed floorplan of the Facility, with a clear indication of the different areas to be used for cultivation; and
- 5. an indicative timetable for the medicinal cannabis harvest cultivation at the Facility.

Where such information relates to the Company's proprietary Model 420IT Rotational Garden Systems (the "Garden Systems") to be installed at the Facility, the Company will cooperate with Canniberia to provide such information to Infarmed in a timely manner.

It is expected that Infarmed will formally issue the Pre-Licence to Canniberia within 30 days after submission of its completed application.

Upon the grant of the Pre-Licence, Canniberia will be permitted to commence build-out and preparation of the Facility for the cultivation of medicinal cannabis, as well as to commence commercial cultivation operations. Within 6 months of the date of the grant of the Pre-Licence, Canniberia must schedule an audit of the Facility by Infarmed for the purpose of obtaining a final lawful cannabis cultivation licence (the "Full Licence"). Once scheduled, it is anticipated that such audit and the corresponding grant of the Full License will take 30 days to complete. The principle compliance requirements of such audit are to confirm that Canniberia's operations conform to the Infarmed-approved written procedures relating to the activities carried out by the licensed entity, namely:

- (i) receipt and storage of controlled substances;
- (ii) plant cultivation and harvesting processes;
- (iii) product traceability records; and
- (iv) facility security.

Infarmed's grant of the Full Licence is conditional on a physical inspection (audit) to ensure the Facility is operating in accordance with the documents submitted to Infarmed and the resulting approved Pre-License.

Key Commercial Terms of Agreement and Indicative Timetable of Pre-Licence

The Agreement includes a technology purchase order for RotoGro's Garden Systems, to be delivered in two separate orders totalling CAD 1.904 million (equivalent to AUD 2.035) ("Purchase Price"). The first order, comprising 72 Garden Systems and 1 RotoGo Fertigation System ("First Order") is to be made by Canniberia within 14 days of the grant of the Pre-Licence and the second order, comprising 72 Garden Systems ("Second Order"), is to be made by Canniberia within 9 months of the grant of the Pre-Licence.

The Purchase Price is to be paid by Canniberia to RGI in 4 instalments as follows:

- 1. the first instalment of CAD 519,500.00 (equivalent to AUD 556,500.00), plus applicable taxes, is due within 5 days of the First Order being made;
- 2. the balance of the Purchase Price is payable in 3 instalments:
 - a. commencing 30 days before the date on which the First Order Garden Systems are made available for shipping to Canniberia;
 - b. 5 days after the date of the Second Order being made; and,
 - c. 5 days after the date on which the Second Order Garden Systems are made available for shipping to Canniberia.

Upon the grant of the Pre-Licence, Canniberia will also commence preparations at the Facility for receiving the 72 Garden Systems comprising the First Order and initial phase of the build out of the Facility.

In addition to the grant of the Pre-License, the Agreement is also conditional upon the parties executing a Growing Management Services Agreement under which the Company and RGWW will provide Canniberia employees and representatives with relevant training to operate the Garden Systems.

An indicative timetable of the Pre-Licence and Full Licence approval process is set out below:
