Westpac Banking Corporation's 2020 Annual General Meeting (AGM) is being held online as a virtual meeting on Friday, 11 December 2020 commencing at 10am (Sydney time), with registration from 9am. You can participate in the AGM either online or by telephone or you may watch a webcast. Details are in the Notice of Meeting.

Shareholders should note that there are three separate websites that are relevant to the AGM.

1. Our AGM website: [westpac.com.au/AGM](http://westpac.com.au/AGM). This contains all the information and documents relevant to the AGM. This includes the Notice of Meeting, Online Platform Guide (how to use the AGM platform) and frequently asked questions. Our webcast (including a replay of the AGM) will also be able to be accessed from here.
2. Our AGM voting website: available via the individual link(s) provided below. This allows you to lodge a direct vote or appoint a proxy to vote at the AGM on your behalf and/or submit a question prior to the AGM.

If you wish to lodge a question prior to the AGM it must be received by 5pm (Sydney time) Thursday, 3 December 2020. Questions submitted should be relevant to the AGM, including on:

- Westpac's financial or non-financial performance;
- the Financial Reports or the Remuneration Report; and/or
- Resolutions being put to the AGM.

The Chairman and CEO will consider these questions when preparing their addresses. Please note that questions submitted prior to the AGM do not form part of the AGM proceedings.

3. The AGM Online Platform: [agmlive.link/WBC20](http://agmlive.link/WBC20). This site allows you to participate in the AGM and can only be accessed on the day (available from 9am). After registering, you can ask a question, watch the AGM and vote in real time. How the website operates is in the Online Platform Guide.

We have set up a separate telephone line to participate in the meeting where you can listen and ask a question. Please note you will not have the ability to vote via the telephone.

**To go to our AGM voting website to lodge a direct vote, appoint a proxy and/or submit a question, please follow these instructions:**

1. Click on the link(s) below. Each link represents a separate shareholding.

2. Enter the postcode (Australian address) or country code (overseas address) relating to each shareholding.
