Appendix 2A - 2017-2020 Long-term Incentive Vesting of Performance Rights

Mastermyne Group Limited (ASX Code: MYE) ("Mastermyne" or "the Company") is pleased to announce the vesting of Performance Rights issued in November 2017, in relation to 2017-2020 Long-term Incentive Plan.

All vesting conditions were achieved over the 3 year measurement period with a total of 427,989 Performance Rights vesting.

Mastermyne Chairman, Col Bloomfield, said "Mastermyne has delivered strong shareholder returns over the last three years with a substantial increase in share price and a resumption of dividend payments. Total Shareholder Return over the period exceeded 16% per annum. In line with this outstanding performance the majority of Performance Rights issued under our Long Term Incentive Plan for this period have vested. This is a well deserved result for the senior leaders of our company who have worked tirelessly to deliver these stellar outcomes."

Mastermyne delivered a Total Shareholder Return of 57.2% over the measurement period. The table below shows how this compared to the selected peer groups.
