Australian Primary Hemp's 'Mt. Elephant' Products to be ranged in 7-Eleven stores

Highlights

- Australian Primary Hemp (APH) secures retail distribution arrangement with 7-Eleven Australia to stock 'Mt. Elephant' branded hemp snack bars
- 7-Eleven Australia is APH's first major retailer of the Mt. Elephant range, exposing the Mt. Elephant brand to over 720 stores and a significant consumer base
- Mt. Elephant hemp seed-and-nut bars will be available in 7-Eleven stores across Australia from 22nd March 2021
- APH and 7-Eleven expect annual sales volume between \$1M – \$1.4M

Melbourne, Australia; 16 November 2020: Australian Primary Hemp Ltd (ASX: APH) ("**APH**" or the "**Company**"), a producer, manufacturer and distributor of premium plant-based health and wellness products, is pleased to announce a retail distribution arrangement with 7-Eleven Australia Pty Ltd ("**7-Eleven**") that will see APH's 'Mt. Elephant' snack bars stocked in stores across Australia.

With over 720 stores across Australia, 7-Eleven is the first large retailer to stock Mt. Elephant products. 7-Eleven stores will carry Mt. Elephant hemp snack bars in three flavours: *Apricot & Nut*, *Honey & Nut*, and *Salted Caramel*, this aligns with the 7-Eleven annual category review process. There is a confirmed promotional program and marketing plan to support sales and consumer awareness being implemented jointly from date of launch. Forecast purchases are confirmed by 7-Eleven for the first six months of ranging.

Mt. Elephant products have been developed to capture the growing consumer demand for high-quality, plant-based 'superfood' products. The seed-and-nut bars contain 100% Australian hemp, a nutritionally dense source of Omega-3 and -6, Magnesium, and Gamma Linoleic acids. In addition to the hemp snack bars, the Mt. Elephant range includes hemp seed oils, protein, flour and dehulled seeds.

7-Eleven and APH expect annual sales volume for the Mt. Elephant snack bars to be between \$1M and \$1.4M.

Commenting on the arrangement with 7-Eleven, APH's Managing Director and Chief Executive Officer, Neale Joseph said, "Since the launch of the Mt. Elephant brand in September, we have received a positive response from retailers, which has resulted in the product range being stocked in over 400 stores nationally to date.
