IBX Secures Additional Capital - Shareholders Exercise Options

MELBOURNE — Imagion Biosystems Limited (ASX: IBX) (the **Company** or **Imagion**) announces that it has received a total of \$250,540.57 for the exercise of Options.

Comprised of \$227,500 for 4,550,000 Listed Options exercisable at 5 cents, expiring on 26 November 2021 and \$23,040.57 for the exercise of 768,019 Listed Options exercisable at 3 cents, expiring on 28 April 2023.
