## RINCON PROJECT UPDATE

- 20 metric tonne >99.5% lithium carbonate product cargo from Argosy's industrial scale pilot plant, scheduled for delivery to Buenos Aires port this coming week
- Salta Province Ministers and local government officials conduct site visit to Argosy's industrial scale pilot plant site
- Follows meeting by local Puna executive team with Salta Governor last week
- Salta government providing support for full development of Rincon Lithium Project
- Further validation of the Company's exclusive and proprietary environmentally clean chemical process technology to produce high purity battery quality lithium carbonate product acceptable for high-specification international markets
