**Think Childcare Group (ASX Code: TNK)**

**Revised indicative proposal from Alceon Group Pty Ltd to acquire 100% of the Think Childcare Group**

---

Think Childcare Group (ASX:TNK) ("**Group**") advises that it has received a revised non-binding and indicative proposal from Alceon Group Pty Ltd ("**Alceon Private Equity**" or "**Alceon**") pursuant to which Alceon or an affiliate would acquire all the issued stapled securities ("**Securities**") of the Group (the "**Revised Alceon Proposal**").

The Revised Alceon Proposal is at an offer price of \$1.75 per security.

Alceon has also confirmed that through associated company NKT Investments Pty Ltd ("**NKT**") it has acquired a relevant interest in approximately 19.23% of Securities in the Group (which has been disclosed to the Group and ASX pursuant to section 671B of the Corporations Act). A copy of Form 603 from NKT dated 23 December 2020 is attached for reference.

The Revised Alceon Proposal includes an offer of all cash consideration or a combination of cash and unlisted shares (subject to caps, scale back provisions and legal/regulatory considerations) in a newly incorporated holding company of the proposed bid vehicle ("**Rolled Equity**").

The Revised Alceon Proposal is subject to securityholders holding at least 20% of Securities agreeing to accept consideration in the form of Rolled Equity. Should securityholders holding more than 30% of Securities elect to receive consideration in the form of Rolled Equity, Alceon would have the right to scale back the Rolled Equity on a pro-rata basis to 30%.

Alceon's preferred structure is to acquire the Securities via Schemes of Arrangement (in conjunction with the acquisition, exercise or cancellation of all outstanding performance rights).



The Revised Alceon Proposal is subject to a number of conditions, including:

- Alceon receiving final credit committee approval from the Group's financiers to roll-over the existing debt facilities;
- entering into mutually acceptable transaction documentation;
- unanimous and continuing recommendation of the Group Directors and their agreement to vote in favour of the proposed Scheme of Arrangement (subject to customary qualifications);
- customary protections to changes in conduct of business;
- all outstanding performance rights being converted into shares, cancelled or acquired;
- Think securityholder approval; and
- court approval.

In addition to the above, Alceon have proposed that the Scheme Implementation Deed would include a break fee payable of 1% of equity value where:

- a third party completes, implements or consummates a competing proposal;
- any Group director recommends that TNK securityholders support a competing proposal;
- a Group director ceases to recommend that TNK securityholders vote in favour of the Revised Alceon Proposal or announces that they do not intend to vote their TNK securities in favour of the Revised Alceon Proposal; or
- TNK Securityholders do not approve the Revised Alceon Proposal.

The Alceon Revised Proposal is also conditional upon the Group ceasing all discussions and due diligence in relation to alternate proposals, in the absence of the Group receiving a new proposal from a third party that is demonstrably superior to the Revised Alceon Proposal.

### **Next steps**

The Revised Alceon Proposal is non-binding and therefore the Board recommends that TNK Securityholders do not need to take any action in relation to the Revised Alceon Proposal at this time.

The Group will keep the market informed in accordance with its continuous disclosure obligations as matters progress.
