MAIDEN AIRCORE DRILLING RESULTS FROM ZULENE AND VIARIA CONFIRMS THICK ZONES OF HIGH GRADE HEAVY MINERAL SAND MINERALISATION

Key Highlights

- Assay results from the maiden aircore drilling program at MRG's Zulene and Viaria Targets confirms depth extension and the high grade THM mineralisation (refer ASX Announcement 13 October 2020).
- Individual 3m interval grades of up to 7.18% THM (20CSAC565) are present in the aircore holes, with multiple consecutive >5% THM over 3m intersections in two of the drillholes (20CSAC565 and 20CSAC568).
- Significant program results include:

• 20CSAC565	0 – 30m	30m @ 4.63% THM (Zulene), including
	0 – 21m	21m @ 5.83% THM;
• 20CSHA568	0 – 30m	30m @ 4.86%THM (Zulene), including
	0 – 27m	27m @ 5.17% THM; and
• 20CSHA571	0 - 30m	30m @ 4.14% THM (Viaria).
- The discovery of thick intersections of high grade THM mineralisation confirms that the Zulene and Viaria Targets warrant more detailed exploration

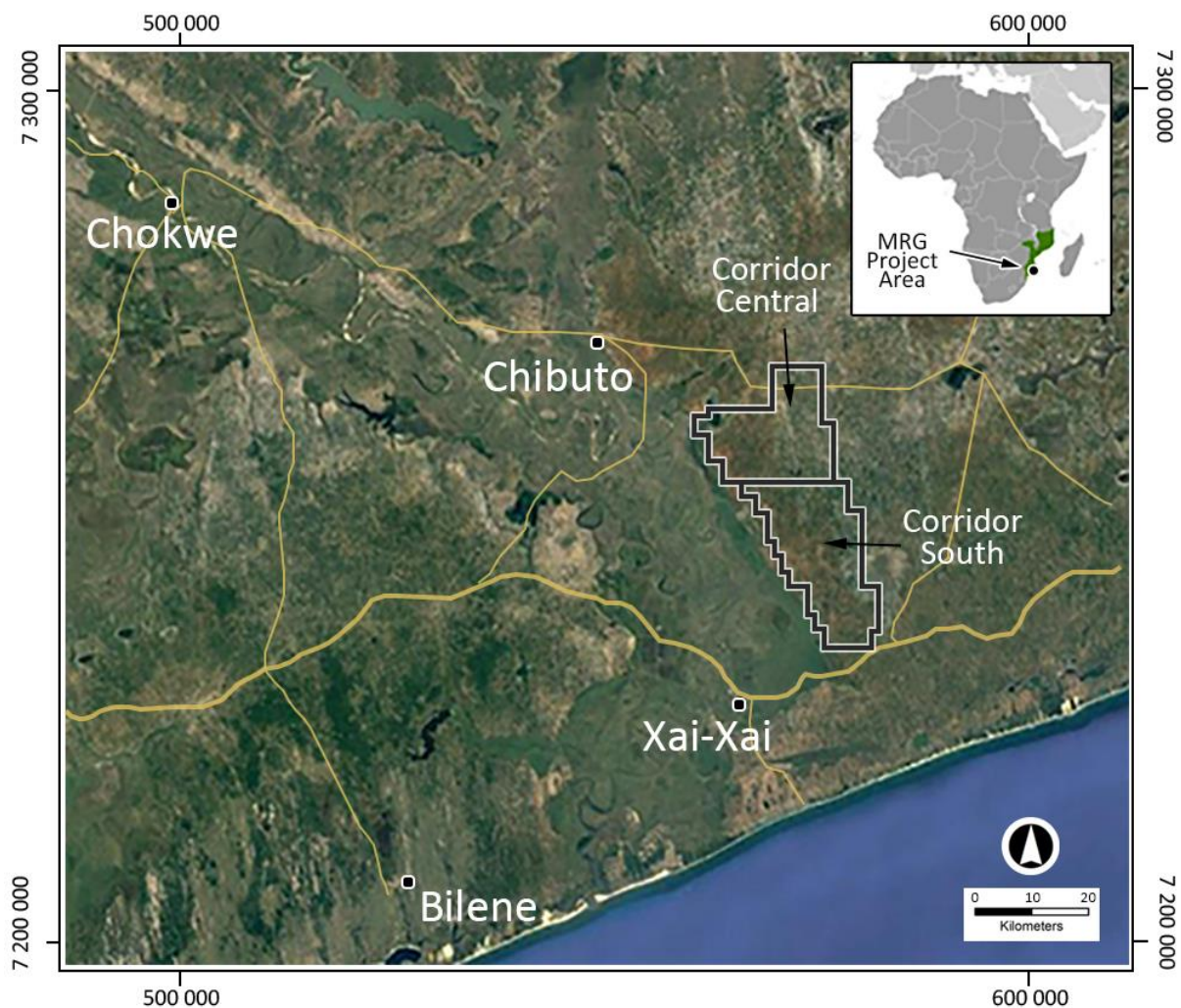


Figure 1: Map of the location of the Corridor Central (6620L) and Corridor South (6621L) Projects.

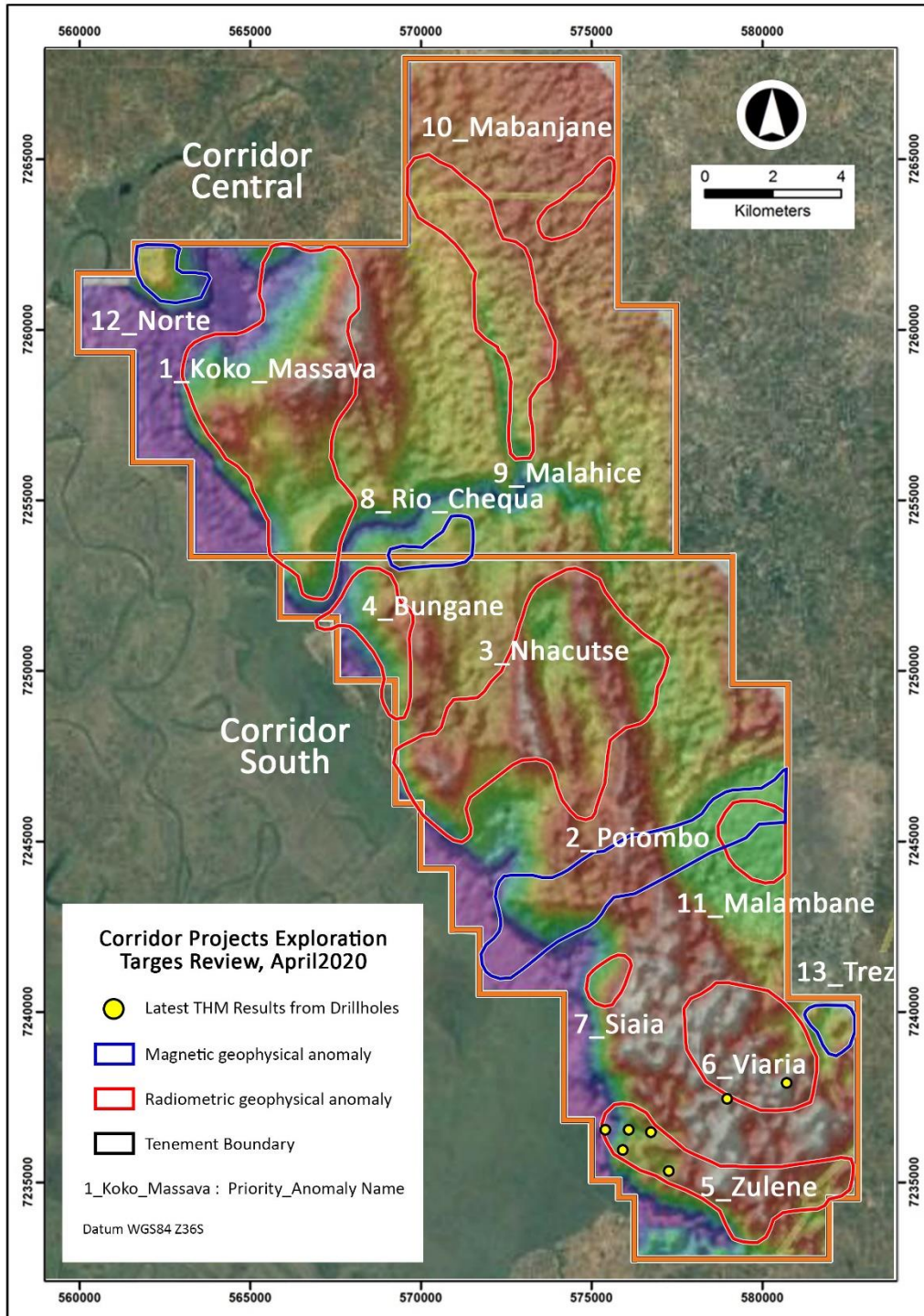


Figure 2: Map of the Corridor Central (6620L) and Corridor South (6621L) Projects showing the positions where the drilling took place.

MRG Metals Limited ("the **Company**" or "**MRQ**") (ASX Code: MRQ) is pleased to announce the assay results from the widely spaced (700m to 2,200m) maiden aircore drilling program on the Company's Zulene and Viaria Targets, located in the Corridor South exploration Licence (6621L, Figures 1 and 2), Mozambique (refer ASX Announcement 13 October 2020).

The drilling program comprised 7 aircore drillholes (Figure 2) for a total of 207m, 5 at Zulene (20CSAC565 to '569) and 2 at Viaria (20CSAC570 to '571). The 5 holes at Zulene ranged in grades from high grade mineralisation (Table 1, 20CSAC565 and 20CSAC568) of >5%THM (when bottom cut of 3% used) to moderate grades in the other 3 holes of +3% THM (when bottom cut of 3% used).

The 2 holes at Viaria returned encouraging results, with both holes returning results with multiple 3m intervals +4% THM (Table 1). Additional follow-up exploration is planned in future.

MRG Metals Chairman, Mr Andrew Van Der Zwan said: "As we round off what has been a very challenging year globally, I am thrilled to report that MRG has finished off on a high note following our very successful exploration programs carried out in Mozambique."

It is with great pleasure that we can advise that the assay results received from our Zulene and Viaria Targets confirm the THM mineralisation and that it continues at depth, meaning we now have another very promising drill target in the mix for prioritization as we kick off 2021 exploration.

I want to thank all of our Shareholders for their continued support throughout the year and hope everyone had a safe and happy Christmas as we look forward to reporting more news from our exciting portfolio of HMS assets in the new year."

Zulene Aircore Drilling Assay Results

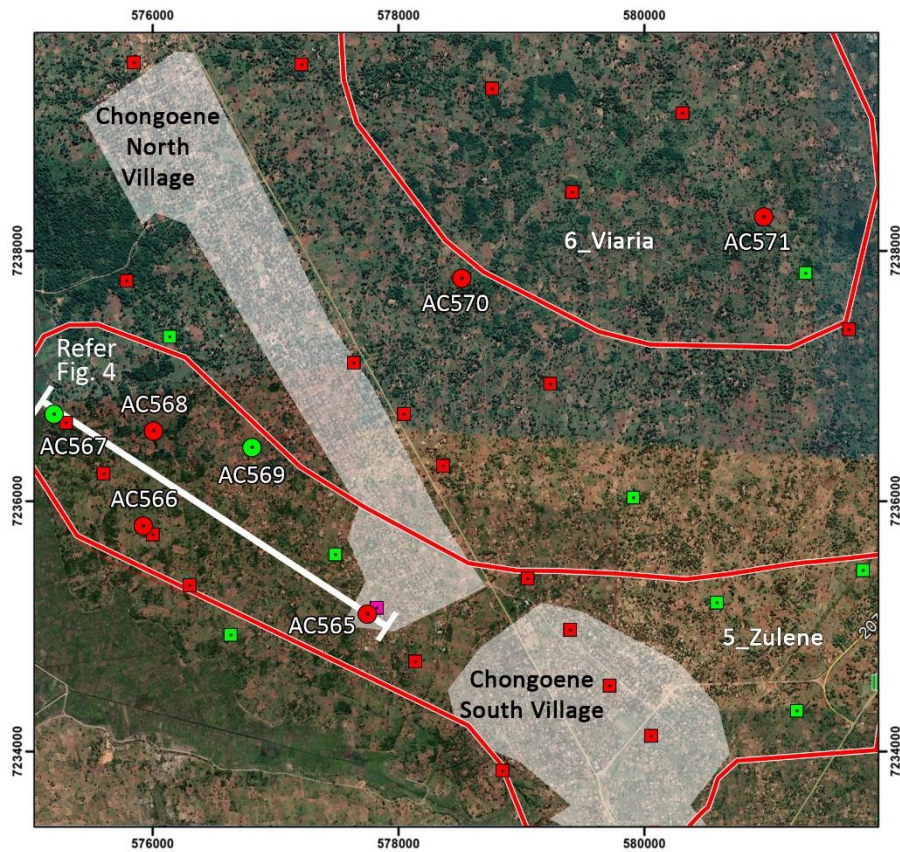
The assay results from the 5 maiden aircore holes at Zulene are very encouraging, with 3 of the 5 drillholes demonstrating uncut grades from surface to the bottom of the drillholes at +3% THM. Using a 3% lower THM cut-off shows all the drillholes having zones from surface with +3.25 % THM (Table 1). The highest individual 3m interval assay result is 7.18% THM from drillhole 20CSAC565; the cut grade from 0 – 21m of 21m @ 5.83% THM from this drillhole is also the highest grade in the drilling program.

The 5 drillholes have now confirmed the Zulene Target as highly prospective for high grade HMS mineralisation. The significant depth extent has also now been confirmed, with drillhole 20CSAC568 with an average cut grade of 5.17% THM from surface to 27m and with 3 of the 5 drillholes having cut grades deeper than 20m depths from surface (Figure 4).

Viaria Aircore Drilling Assay Results

The assay results from the 2 maiden aircore holes at Zulene are likewise very encouraging, with both drillholes with uncut grades to the bottom of the drillholes at +3.15% THM and 20CSAC571 having +3% THM grades from surface to the end of hole at 30m; returning high grade results of 0 – 30m of 30m @ 4.14% THM (Table 1).

The 2 drillholes have confirmed the potential of the Viaria Target and has also confirmed the significant depth extent of the mineralisation. Additional aircore drilling will have to take place on this Target in future.

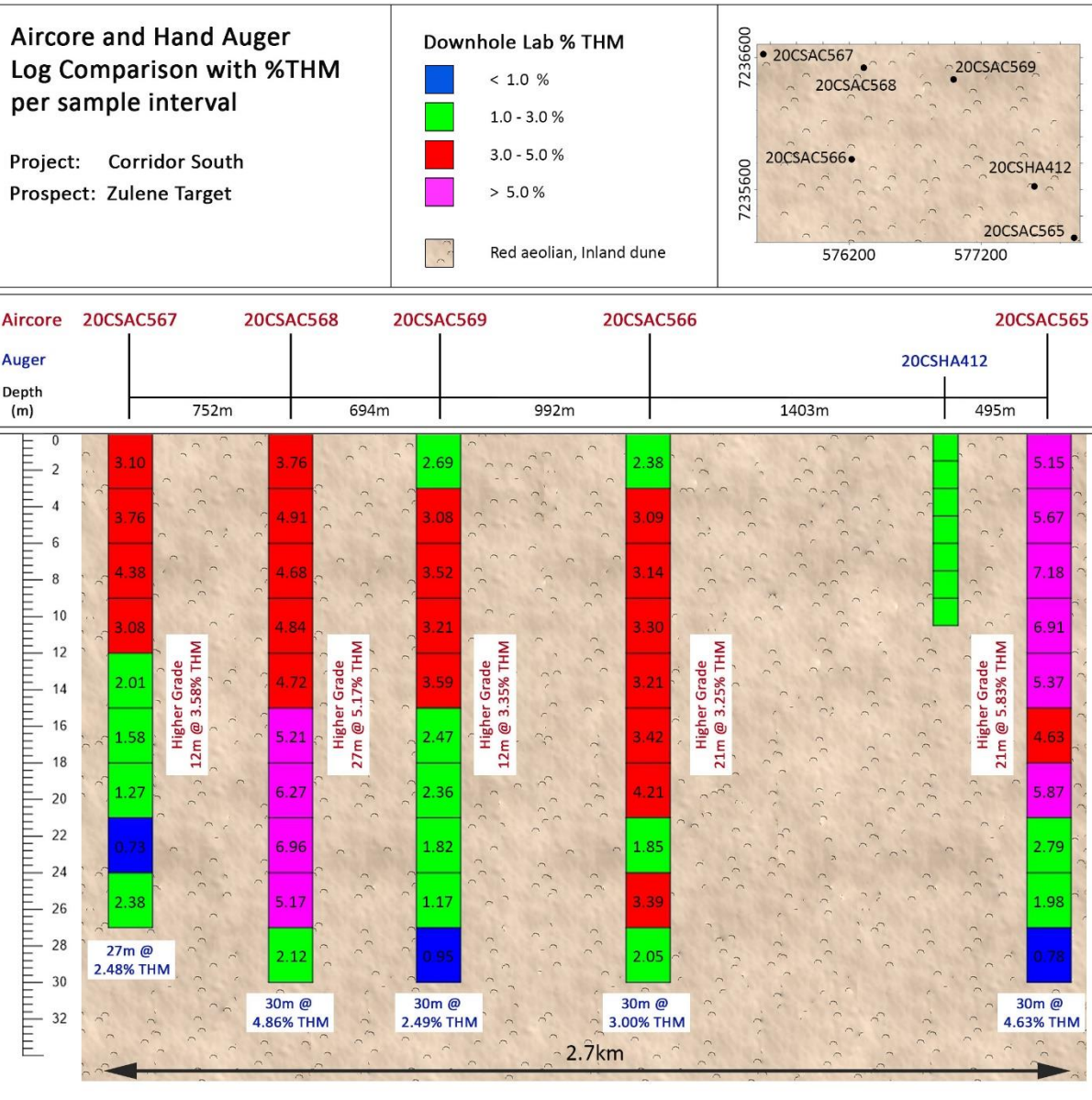

Visual estimated THM grades versus assay results

A comparison of the reported visible (VIS) % THM grades from the 7 aircore drillholes in this program (refer ASX Announcement 13 October 2020) to the actual assay results on averages per drillholes basis from this announcement shows a good correlation, with on average an overestimation on the VIS versus actual assay results of only 0.16% THM on the average drillhole grades.

On individual drillholes, 6 of the 7 drillholes have VIS estimates within 0.5% THM of the actual assay results, with only 1 hole at an overestimation of 0.54% THM. The estimations on higher grades of +5% THM are less accurate, the specific hole with the 0.54% overestimation is a hole with average grades +5% THM. The correlation in this batch of results is very good and supports the use of VIS estimated THM grades for reporting and planning.

Unusual commodities or mineralisation types (eg submarine nodules) may warrant disclosure of detailed information.	- Aircore drilling was used to obtain samples at 3.0m intervals. - The larger 3.0m interval aircore drill samples were homogenized by rotating the sample bag prior to being grab sampled for panning. - A sample of sand, approximately 20g, was scooped from the sample bag of each sample interval for wet panning and visual estimation. - The same sample mass is used for every pan sample visual estimation. - The consistent sized pan sample is to ensure visual calibration is maintained for consistency in percentage visual estimation of total heavy mineral (THM). - Images of pan concentrate samples with associated laboratory THM results are used in the field as comparisons to further refine visual estimation of THM. - Geologists enter the laboratory THM results for each sample on field log sheets against the visual estimation of THM to refine and further calibrate field visual estimation of THM. - Geotagged photographs are taken of each panned sample with the corresponding sample bag to enable easy reference at a later date. - A sample ledger is kept at the drill rig for recording sample intervals and sample mass, and photographs are taken of samples for each hole to cross-reference with logging. - The large 3.0m drill samples have an average of about 18kg, range 8-40kg, and are being split down in Mozambique to approximately 300-600g using a three tier riffle splitter for export to the Primary processing laboratory.
Drilling techniques	Drill type (eg core, reverse circulation, open-hole hammer, rotary air blast, auger, Bangka, sonic, etc) and details (eg core diameter, triple or standard tube, depth of diamond tails, face-sampling bit or other type, whether core is oriented and if so, by what method, etc).	- Reverse Circulation 'Aircore' drilling with inner tubes for sample return was used. - Aircore drilling is considered a standard industry technique for heavy mineral sand (HMS) mineralization. Aircore drilling is a form of reverse circulation drilling where the sample is collected at the face

		and returned inside the inner tube. - Aircore drill rods used were 3m long. - Drill rods used were 76mm in diameter and NQ diameter (80mm) Harlsan aircore drill bits were used. - All drill holes were drilled vertical. - The drilling onsite is governed by an Aircore Drilling Guideline to ensure consistency in application of the method between geologists.
