### Synertec Wins Project Award with Beon Energy Solutions in Target Markets of Water and Renewable Energy

**Melbourne, Australia:** Engineering product and solution provider, Synertec Corporation Limited (ASX: SOP, "Synertec" or "the Company") is pleased to advise that the Company has signed a contract for works with Beon Energy Solutions ("Beon") relating to a contract to support a major energy upgrade project for Synertec's long-standing client and one of Australia's major bulk water suppliers, Melbourne Water.

#### Highlights:

- Synertec awarded contract for works with new customer, Beon Energy Solutions, to design, supply and install automation control systems to support solar power plants under construction at two major (one proposed, pending planning approval) Victorian water infrastructure sites operated by mutual customer, Melbourne Water
- Beon is a leader in the deployment of large-scale energy and infrastructure projects, and is backed by global infrastructure leader CK Infrastructure with over \$170 billion market capitalisation
- Contract builds upon Synertec's long-standing experience providing critical solutions to key Australian water infrastructure sites

#### Project Background

Synertec has been awarded a contract with Beon, Melbourne Water's preferred contractor for construction on a solar farm project.

The project will develop solar photovoltaic generation plants at two critical water treatment plants in Victoria, with the objective to reduce operational costs associated with electricity usage and to lower greenhouse gas emissions. This will assist in Melbourne Water's pledge commitment to reduce its net carbon emissions as per the pledge to zero by 2030. The planned solar farms aim to deliver peak electricity supply of 20 MW and 10 MW, respectively.

#### Synertec's Engagement

Synertec has been engaged by Beon to design, supply and install programmable automation control systems through which Melbourne Water can integrate and remotely control site devices, including inverters, a power plant controller, trackers and weather equipment. Synertec will focus its expertise in water engineering project management and maintenance to work with Beon to provide Melbourne Water with full control of its new solar power system.
