**Australian Ethical reaches \$5 billion milestone in funds under management**

### FUM movement for the quarter

Australian Ethical increased funds under management (FUM) by 16.9% to \$5.05 billion for the quarter ended 31 December 2020, up from \$4.32 billion as at 30 September 2020. The increase was driven by exceptional investment performance and strong netflows.

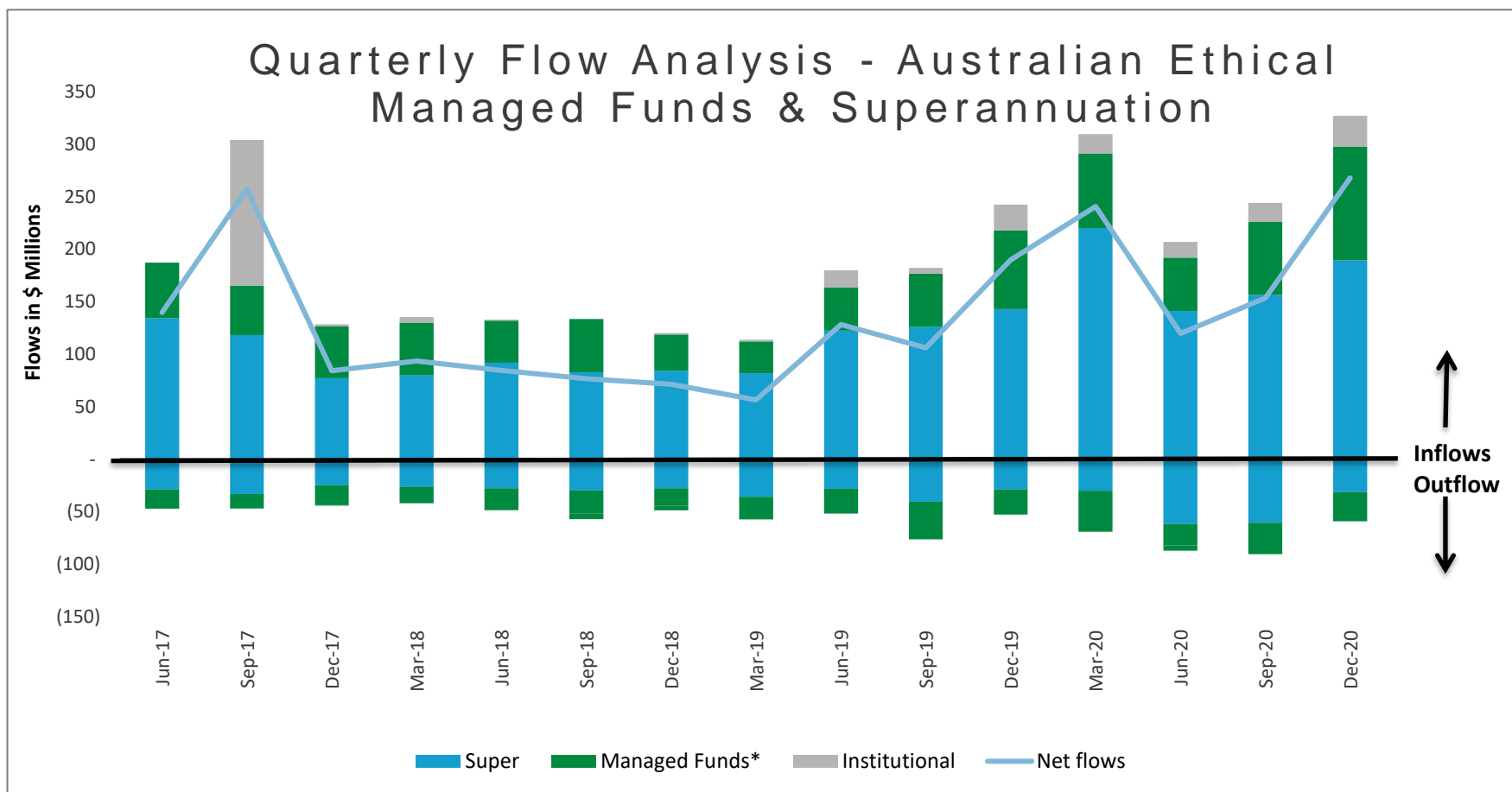
