## ASX Release

### Liquefied Natural Gas Limited ACN 101 676 779 (Subject to Deed of Company Arrangement)

#### Further extension of Deed of Company Arrangement Sunset Date

Reference is made to the ASX announcement dated 9 October 2020 that Liquefied Natural Gas Limited (ASX:LNG) (**Company**), together with four of its wholly owned subsidiaries, LNG International Pty Ltd (ACN 099 217 455), LNG Technology Pty Ltd (ACN 115 455 788), Mayflower LNG Pty Ltd (ACN 145 733 071) and North American LNG Pty Ltd (ACN 145 961 306) (collectively **Companies**), had executed a Deed of Company Arrangement (**DOCA**) on Thursday, 8 October 2020.

On 14 December 2020, the Company announced that the DOCA proponent, Aureus LNG GmbH (**Aureus**), had been granted an extension to the date by which the conditions precedent for the effectuation of the DOCA need to be satisfied (**Sunset Date**) by the Deed Administrators in accordance with the provisions of the DOCA until 5:00pm AEDT on 18 December 2020.

On 24 December 2020, the Company announced that pursuant to the provisions of the DOCA a further extension to the Sunset Date had been granted until 5:00PM AEDT on 15 January 2021.

Following concurrent meetings of the Companies' creditors on 15 January 2021, a further extension of the Sunset Date has been granted pursuant to the provisions of the DOCA until 5:00PM AEDT on 29 January 2021.

A copy of the DOCA has been lodged with the Australian Securities and Investments Commission in accordance with Section 450B of the *Corporations Act 2001*. A copy of the DOCA and other relevant information can be found on the Deed Administrators' website:
