IBX Secures Additional Capital - Shareholders Exercise Options

MELBOURNE — Imagion Biosystems Limited (ASX: IBX) (the **Company** or **Imagion**) announces that it has received a total of \$369,689.99 for the exercise of options.

Comprised of \$75,620.00 for 1,512,400 Listed Options exercisable at 5 cents, expiring on 26 November 2021 and \$294,069.99 for the exercise of 9,802,333 Listed Options exercisable at 3 cents, expiring on 28 April 2023.
