### RCR awarded Crushing & Conveying contract for Fortescue Metals Group

NRW Holdings are pleased to announce that wholly owned subsidiary RCR Mining Technologies have been awarded a new contract for the Design and Construction of a Primary Crushing Plant (PCP) and Overland Conveyor (OLC) for the Queens Project at the Solomon Hub for Fortescue Metals Group. The contract has a combined value of approximately \$80 million.

After successful delivery of the Hopper 9 Crushing Facility at Fortescue's Cloudbreak mine earlier in 2020 this award is strategically significant for the business as it showcases our engineering led delivery of innovative solutions.
