Answer: No, because the Company has completed most of its cash outgoings with respect to its drilling programme for the year in this quarter. Expenditures are expected to be substantially lower in the next two quarters, as the Company completes its PFS study

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company has enough cash to continue its planned activities for the next quarter. The Company has 103 million share options outstanding, exercisable at a price of \$0.20, for an amount of \$20.6M. These options are currently in the money and are exercisable by end March 2021. Furthermore, the Company has executed an Underwriting agreement and along with commitments from Atrum Directors, the Company is expected to raise \$20.6M by end of March 2021.

Answer: Based on its expected expenditure level and the capital raise it expects to successfully complete, the Company will be able to continue its operations and meet its business objectives.
