**Atlas Pearls: September 2020 Quarterly Update and Appendix 4C**

Atlas Pearls Ltd (ASX: ATP) ("Atlas" or "the Company") today announces an update for the Quarter Ending 31 December 2020.

**October to December 2020 Quarterly Results**

Key items to note for the quarter are:

- Sales events for the quarter delivered revenue of \$5.2m.
- The Company launched its online auction platform in November with a first full harvest online auction held in December 2020. Clients participated in the online auctions from all over the world including Australia, New Zealand, Japan, China, the USA and Spain. Whilst this new sales channel is still in the development phase, early indication suggests that this innovative avenue to market is worth progressing.
- International pearl market conditions remain challenging, with selling prices remaining stagnant in most sectors but some markets are beginning to show signs of improvement.
- Seeding of oysters remain in line with expectations.
- The Company's revised harvest schedule remains at the 24-month cultivation time (to allow for full pearl development) and, despite logistical challenges from various COVID lockdowns, the Company has harvested 170,000 pearls during the quarter.
- During the quarter, the Company spent \$3.9m on pearling operations including \$1.8m on product manufacturing and operating costs and \$1.5m on staff costs. Please refer to section 1 of the Appendix 4C.
- Related party payments during the quarter total \$11k which relates to the payment of Director fees. Please refer to section 6 of the Appendix 4C.

**January to March 2021 Outlook**

Key items of note for January to March 2021 are:

- The Company will host its next online auction on 17-18 February. The auction is open for any business that registers for the event.
- Private sales and Indonesian auctions are scheduled for March 2021.
- The Company expects to harvest 150,000 pearls in the March quarter.
- Atlas aims to continue its strategic advantage by promoting pearls "from the source" and ensuring that pearls are always in a distribution network.

1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: The Company expects future sales events from February to June to improve as a large quantity of pearls are being harvested that are showing an improved quality. Diverse distribution networks are being explored which are showing encouraging results.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company does not believe further funding is required as the combination of improved harvest quality and new distribution networks are forecast to fund working capital requirements.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: There is an expectation of improved revenue from a combination of larger pearl sizes, improved pearl quality and increased pearl numbers. The Company has established new distribution channels to access the pearl market more directly.
