### **Amended Appendix 4C**

The Company wishes to advise that an amended Appendix Form 4C has been lodged.

The Company has re-classified **Loss of control over subsidiaries from 11 December 2020 \$857k** from Cash Flow from Operating Activities to Cash Flows from Financing Activities.
