



6000m RC Drill program underway at Woodline Projects

Highlights:

- 6000m RC drilling program has commenced at Woodline;
- RC Program complements the current Diamond Drilling program and is designed to test dip and strike extensions within the 20Km+ defined geochemical anomaly at Grindall and Redmill;
- RC Program to further test Socrates, West Socrates and East Socrates projects;
- Multiple geophysical anomalies being drill tested;
- First exploration drill results from both RC & Diamond programs are expected in early March;
- Nelson's RC & Diamond drill rigs provide flexibility and cost-effective drilling with multiple 2021 campaigns forecast.

Nelson Resources Limited (ASX: **NES**) (**Nelson** or **the Company**) is pleased to provide this drilling update for its 100% owned Woodline project in the Fraser Range, Western Australia.

The Company is pleased to announce it has commissioned its second drilling rig (RC rig) to complement its currently operating diamond drilling rig. The current 68-hole 6068m RC drill program is designed to confirm the gold mineralisation potential of multiple drill targets including the 20Km+ geochemical anomaly and multiple geophysical anomalies previously identified by the Company and Sipa/Newmont.

The 20Km+ geochemical anomaly is positioned in the hanging wall of the Albany Fraser Orogen with the Tropicana Gold mine being situated in the same structural geological setting.

Previous RC Drilling at Grindall and Redmill intercepted gold mineralisation, however the strike and dip of the potential gold bearing structures has yet to be defined. These structures are currently being tested by the company with its 1000m to 1500m diamond drilling program. Initial Diamond Drilling and RC samples are planned to be submitted late next week. The combined Diamond and RC program is also designed to further test the gold potential of the company's Socrates, West Socrates and East Socrates projects approximately 20Kms to the North of the Grindall and Redmill projects.

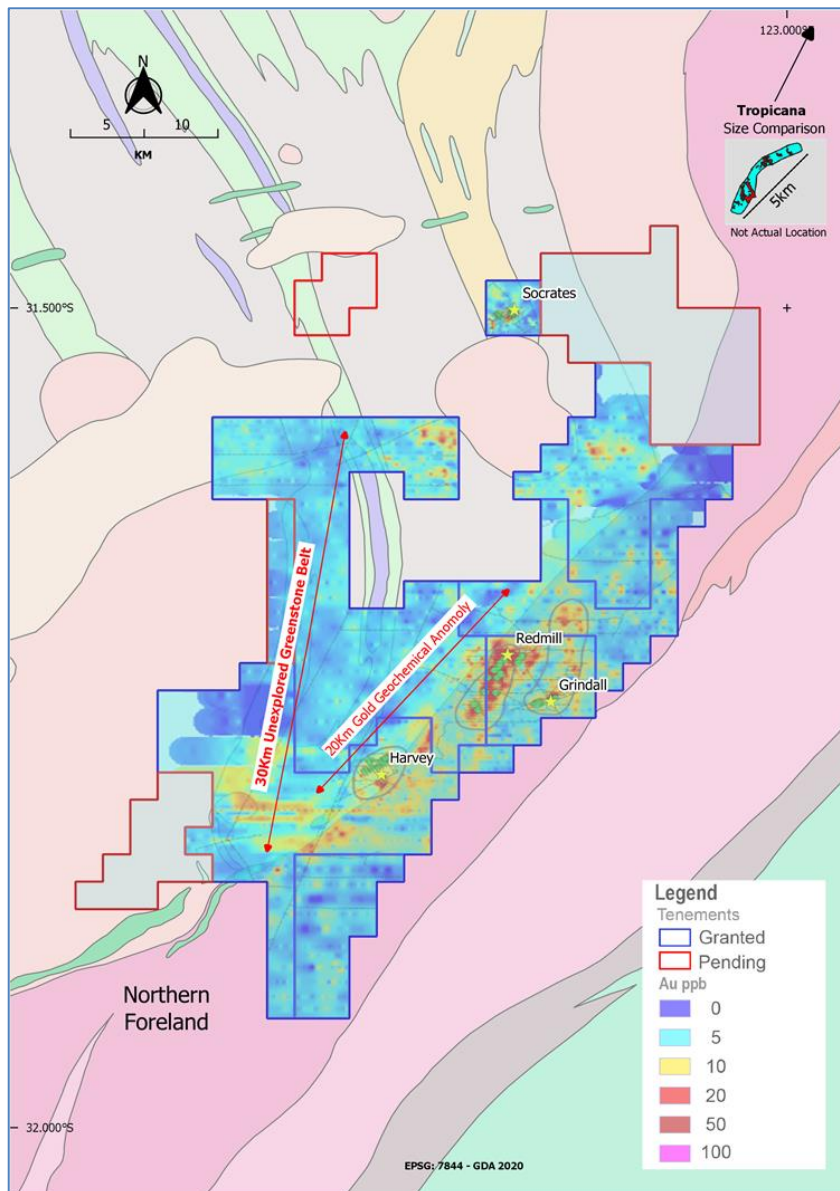
