### **IBX Secures Additional Capital - Shareholders Exercise Options**

**MELBOURNE** — Imagion Biosystems Limited (ASX: IBX) (the **Company** or **Imagion**) announces that it has received a total of \$245,059.82 for the exercise of options.

Comprised of \$175,110.35 for 3,502,207 Listed Options exercisable at 5 cents, expiring on 26 November 2021 and \$69,949.47 for the exercise of 2,331,649 Listed Options exercisable at 3 cents, expiring on 28 April 2023.
