



Completion of \$11.44M Placement

Issue and Allotment of 95,333,357 Shares

On 24 February 2021, Helios Energy Ltd (ASX Codes: HE8, HE8OA) (**Helios** or **Company** or **Issuer**) advised that it has conducted a capital raising of \$11,440,003 by way of the issue of 95,333,357 shares at a price of 12 cents per share (**Placement**). The Placement was made to sophisticated and professional investors under the provisions of section 708 of the Corporations Act 2001 (Cth). The Placement was conducted within the 15% placement capacity available to the Company in accordance with ASX Listing Rule 7.1.

The Company has completed the issue and allotment of 95,333,357 shares at 12 cents per share to raise \$11,440,003.

An Appendix 2A in respect of the issue and allotment of these 95,333,357 shares is attached.

Use of Placement Proceeds

The funds raised from the Placement will be used for working capital purposes and to purchase additional oil and gas leases in the Presidio Oil Project located in Presidio County, Texas, USA.

Capital Raising Fees

In addition to the payment of standard commercial capital raising fees, the Company has issued 400,000 shares to those brokers who assisted with the \$11,440,003 capital raising. An Appendix 2A in respect of the issue and allotment of these 400,000 shares is also attached.

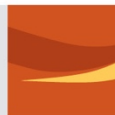
