# Tulla Resources PLC (ASX: TUL) – Admission and Commencement of Official Quotation

### **Description**

Tulla Resources PLC ('TUL') was admitted to the Official List of ASX Limited ('ASX') today, Wednesday, 17 March 2021.

TUL raised \$78,300,000 pursuant to the offer under its prospectus dated 24 February 2021 and supplementary prospectus dated 4 March 2021 (together, the 'Prospectus') by the issue of 87,000,000 shares (to be settled on ASX in the form of CDIs) at an issue price of \$0.90 per CDI.
