## IBX Secures Additional Capital - Shareholders Exercise Options

**MELBOURNE** — Imagion Biosystems Limited (ASX: IBX) (the **Company** or **Imagion**) announces that it has received a total of \$81,256.85 for the exercise of options.

Comprised of \$37,456.85 for 749,137 Listed Options exercisable at 5 cents, expiring on 26 November 2021 and \$43,800.00 for the exercise of 1,460,000 Listed Options exercisable at 3 cents, expiring on 28 April 2023.
