## IBX Secures Additional Capital - Shareholders Exercise Options

**MELBOURNE** — Imagion Biosystems Limited (ASX: IBX) (the **Company** or **Imagion**) announces that it has received a total of \$164,754 for the exercise of options.

Comprised of \$110,919 for 2,218,380 Listed Options exercisable at 5 cents, expiring on 26 November 2021 and \$53,835 for the exercise of 1,794,500 Listed Options exercisable at 3 cents, expiring on 28 April 2023.

The exercise of these options has resulted in the issue of 4,012,880 fully paid ordinary shares, as outlined in the attached application for quotation (Appendix 2A).
