IBX Secures Additional Capital - Shareholders Exercise Options

MELBOURNE — Imagion Biosystems Limited (ASX: IBX) (the **Company** or **Imagion**) announces that it has received a total of \$164,754 for the exercise of options.

Comprised of \$110,919 for 2,218,380 Listed Options exercisable at 5 cents, expiring on 26 November 2021 and \$53,835 for the exercise of 1,794,500 Listed Options exercisable at 3 cents, expiring on 28 April 2023.
