8.6.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: The Current Quarter's net operating cash outflows includes approximately \$1 million of one-off cash outflows related to capital purchases and recruitment. Excluding these one-off outflows, the funding available would be nearly 2.3 quarters.

Answer: The company continually reviews proposals from a range of parties looking to invest. These opportunities, amongst others, will continue to be part of the company's strategy to fund future operations and growth.

Answer: The company continues to develop and invest in global sales capability through the addition of new commercial managers in Hong Kong and Queensland. With the expanded global outlook, the company aims to achieve its strategic objectives.
