## IBX Secures Additional Capital - Shareholders Exercise Options

**MELBOURNE** — Imagion Biosystems Limited (ASX: IBX) (the **Company** or **Imagion**) announces that it has received a total of \$44,545.32 for the exercise of options.

Comprised of \$23,223.90 for 464,478 Listed Options exercisable at 5 cents, expiring on 26 November 2021 and \$21,321.42 for the exercise of 710,714 Listed Options exercisable at 3 cents, expiring on 28 April 2023.
