

## ASX Announcement

### Notice Under Section 708A(5) of the Corporations Act 2001

This notice is given by Dynamic Drill and Blast Holdings Limited (**Dynamic** or **The Company**) in relation to the issue of 13,787,905 fully paid ordinary shares on 31 May 2021 to professional and sophisticated investors each at an issue price of \$0.45 pursuant to the placement announced on 24 May 2021 (**Shares**) as detailed in the attached Appendix 2A.
