

APPENDIX 4C FOR QUARTER ENDED 31st MARCH 2021

22 June 2021: Property Connect Holdings Limited (ASX: PCH) ('Property Connect' or 'the Company') today lodged its Appendix 4C quarterly report of cash flows for the quarter ended 31 March 2021 with the Australian Securities Exchange (ASX).

Property Connect reported a cash balance of \$93,000 at 31 March 2021.

Net operating cash flow for the quarter was \$25,000, representing an R & D refund of \$133,000 and and the Company's ongoing operational activities. Related party payments of \$18,000 were paid during the period, which represent director's fees paid to Non-Executive Directors.

There were no substantial business activities during the period. Operational costs continued to be kept to a minimum during the period while the Company continued to seek a transaction which will satisfy Chapters 1 and 2 of the Listing Rules and the ASX's requirement for reinstatement to the Official List. Whilst the Company continues to seek a transaction which will satisfy these requirements there is no guarantee that the securities of the Company will be reinstated and if so, when.

The lodgement of this Appendix 4C quarterly report of cashflows has been delayed due to administrative delays in preparing and finalising the information.
