## RESULTS OF ANNUAL GENERAL MEETING

**24 June 2021** – Drones-as-a-service provider Delta Drone International Limited (**ASX:DLT**) (the **Company**) held its Annual General Meeting today, 24 June 2021 at 4.00pm (AEST).

The resolutions were voted in accordance with the Notice of Annual General Meeting previously advised to the Australian Securities Exchange with all applicable resolutions being passed by a poll. Resolution 6, for the approval of an additional 10% placement capacity, was passed by a sufficient majority as a special resolution.

As announced on 22 June 2021, Resolution 12 was withdrawn following the resignation of Dan Arazi as a director of the Company.
