**IMPORTANT INFORMATION REGARDING UPCOMING FY2020 ANNUAL GENERAL MEETING**

The Annual General Meeting for 8VI Holdings Ltd (the “Company” or “8VI”) is scheduled to be held at 47 Scotts Road, Goldbell Towers #03-03/04, Singapore 228233 on Tuesday, 27 July 2021 at 1.30pm SST (“Meeting”).

At the Meeting, shareholders will be asked to consider and vote on the matters listed in the Notice of Meeting announced on ASX. Holders of our CHESSE Depository Interests over ordinary shares (“CDIs”) will also be entitled to attend the AGM, provided that they cannot vote at the Meeting and if they wish to vote they must direct CHESSE Depository Nominees Pty Ltd (“CDN”) to vote in advance of the meeting pursuant to the instructions set forth in the CDI Voting Instruction Form (“VIF”).

**In light of the evolving COVID-19 situation and Government restrictions on public gatherings in place at the time of the Meeting, the Directors have made a decision that all Securityholders will not be able to attend the AGM in person.**

**The Meeting will be held via teleconference, and all Securityholders for 8VI are encouraged to attend the virtual meeting. To attend the Meeting, all Securityholders will need to pre-register by 23 July 2021, 12.59pm SST: <https://8vi.link/8viprereg2021>**

**Please note that all Securityholders will not be able to ask questions at the AGM during the virtual meeting. Questions may be submitted in advance instead to [ir@8viholdings.com](mailto:ir@8viholdings.com) by 23 July 2021, 12.59pm SST.**

  - Enter your Securityholder Reference Number (SRN) or Holder Identification Number (HIN), this can be found on your Voting Instruction Form;
  - Enter your postcode (if you have an Australian address), select your country (if you have an overseas address) and complete the security validation process;
  - Tick the box regarding the terms and conditions
- Once you are logged in, click on 'Communications' from the top menu and select 'Preferences'. From here you can select your Communication Preference and update your email address.

The directors strongly encourage all CDI holders to submit your voting instructions to CDN by the provision of a completed CDI voting instruction form to Link Market Services Limited, 48 hours before the start of the meeting i.e. before Sunday, 25 July 2021 at 1.30pm SST.

Securityholders may participate at the AGM by:

- Observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;

- Appointing the Chairman of the AGM as proxy to attend, speak and vote on their behalf at the AGM.
