## **BUSINESS OVERVIEW**

Citigold Corporation Limited (Citigold) is an Australian gold mining and exploration company, operating on the high-grade Charters Towers Goldfield in north-east, Queensland Australia.

The Company's prime focus is the Charters Towers Gold Project.

The Project comprises of the 14 million ounce gold deposit, with an Inferred Mineral Resource of 32 million tonnes at 14 grams per tonne gold and 620,000 ounces of gold in the Probable Ore Reserve (2.5 Mt @ 7.7 g/t Au at a 4 g/t cut-off). See ASX announcement dated 9 December 2020 Mineral Resources and Ore Reserves 2020.

The Charters Towers Project is one of Australia's largest high-grade pure gold deposits.

The Company does not require additional mine acquisitions to sustain long-term gold production. Citigold has already invested over \$200 million in acquiring the gold deposit, developing the infrastructure and test mining at Charaters Towers, producing over 100,000 ounces of gold.

The Company is seeking to raise the required capital funding to complete the underground capital works to commercialise its gold deposit.

The Charters Towers gold deposit is large and forecasts show that it has the potential to generate substantial positive cash flows for decades. This will help generate returns for all shareholders over time.



## **CHAIRMAN'S LETTER**

Dear Shareholders.

On behalf of your Board, I am pleased to present Citigold's Annual Report for the 2021 Financial year, detailing our continued progress in delivering on your Company's objective.

Having been at Charters Towers several times this period I can report first hand on progress.

This year has seen a number of positive developments including:

- Release of the Mineral Resources and Ore Reserves Report
- Gold Resources increase 27% to 14 million oz<sup>1</sup>
- Mine design and engineering continue to advance

Our broad regional exploration program delivered encouraging results with potential for mineralised bodies on our ground to the north of Central, and a base metal and silver signature result to the south that more closely matches a volcanogenic massive sulphide (VMS) than the traditional Charters Towers style of mineralisation.

Central mine engineering and design work for restarting the mine continued to be an area of focus. The revised whole of mine designs and schedules continues to be optimised for initiatives' including twin-declines, ore handling systems, and advancements in technologies and innovations. Taking this long-term design and whole of life of mine approach aims to maximize production and deliver shareholder value.

We thank our existing shareholders and welcome new shareholders. My sincere thanks to our inspiring personnel, suppliers, and the Charters Towers Community.

As we move through 2021 our focus and determination remain very strong to advance and ultimately restarting our world-class gold mine.



## **REVIEW OF OPERATIONS**

## MINING OPERATIONS

- The period saw a focus on the upside potential for exploration areas held by the Company that surround our production leases that have along strike potential for extensions of existing mineral resources.
- Inferred Mineral Resources have increased 27% to 14 million ounces (Previously: 11 million ounces) and Ore Reserves remain unchanged during the period (See ASX announcement dated 9 December 2020, Mineral Resources and Ore Reserves 2020).
- A geochemical sampling program was completed at the end of December 2020 with assay results being returned. The results have highlighted the potential for new undiscovered mineralised bodies to the nearby north of the Central reefs and a different style of mineralisation to the south (See ASX announcement dated 19 January 2021, Exploration Program).
- The Company and its mining engineering consultants, Prospector Enterprises, continued to update the mine design with data for the Central Mine being reviewed and optimised because of improved technologies not previously available.

Our aim is to be a 300,000 plus ounces per annum ultra-low-cost gold producer in five years using state of the art technologies and efficiencies, all with the aim of returning substantial profits to shareholders in harmony with the local environment. Citigold continues to advance discussions with major strategic funding partners in developing the production-ready Charters Towers Gold Project. The period has seen an improvement in the gold price indicating an increased appetite for gold by investors.

The Charters Towers Gold Project still remains one of Australia's largest high-grade pure gold deposits.

#### CENTRAL MINE OPTIMISATION

In consultation with project designers, an innovative mining system has been put together that takes an efficient 'keyhole mining' approach to our mining and thereby doing what needs to be done for the geometry of our ore system, which in itself is somewhat unique. Make small excavations, and just extract the valuable ore minimising dilution and processing less waste.

The previously reported planned use of two small declines, commencing circa 1,300 metres down the current single decline has, further advanced. The 'twins' require smaller blasts, excavate less rock than a single standard decline and therefore less rock to move. The declines will allow flexibility for ventilation, emergency egress, material and personnel movements in and out of the underground.



A further advantage of the 'twin declines identified previously is that this approach may allow more efficient access to multiple areas of the underground reefs. This could allow the 'twins' to multiply gold production ore extraction in multiple areas of the mineralisation earlier than was possible under the old 'single' tunnel. The design possibilities will be further investigated. Preliminary costs indicate the 'twin' smaller declines are within the existing budget.

It is interesting that as we investigate 'greener' ways to mine, new cost reduction opportunities emerge.

To ensure harmony with the environment the mine will eventually be renewables powered. Potential sites were selected and the possibilities for 'captive' off-grid renewables were considered to be favourable. There are additional upfront capital costs, that need to be amortised, but then the 'energy' costs are essentially free. This is an evolving change from the earlier 'independent' development of these renewable assets.

## PROCESSING PLANT

During the period a site was selected, for an innovative Citigold gold ore processing plant using the latest recovery processes.

The land is already under mining lease adjacent to our previously mined open-pit (now a water storage).

The evolving new process plant design will focus on the 'upgrading' of ore to remove the bulk of the granite 'dilution' that naturally occurs during the underground mining process. The Company's existing water pipeline will be extended to the new processing site. Based on known mineral resources, the mine the Company is building is planned to produce for many decades.

Citigold's project team visited the planned 'Process Plant' site (see picture on page 7) during the period to conduct survey work to assist continued project development.

Citigold envisages its new plant will be an efficient design, environmentally friendly, requiring significantly less surface footprint, using less water and renewable energy powered compared to traditional process plants.

## **CORPORATE**

During the 2021 Financial Year, the Charters Towers Gold Project remained the Company's prime focus.

Our aim is to be a 300,000 plus ounces per annum ultra-low-cost gold producer in five years using state of the art technologies and efficiencies, all with the aim of returning substantial profits to shareholders in harmony with the local environment.

The Charters Towers Gold Project still remains one of Australia's largest high-grade pure gold deposits.

The Project comprises of the 14 million ounce gold deposit, with an Inferred Mineral Resource of 32 million tonnes at 14 grams per tonne gold and 620,000 ounces of gold in the Probable Ore Reserve (2.5 Mt @ 7.7 g/t Au at a 4 g/t cut-off). The critical assumptions and technical parameters underpinning the estimates continue to apply and have not materially changed.

During the year there was heightened activity with regards to reviewing and deciding on our innovation mining approach. This builds upon the constraints for previous test mining operations, to innovate efficiencies and build a future technology-driven gold mine.

## FINANCIAL HIGHLIGHTS

As at 30th June 2021, the loss after tax for the Company was \$1.4 million for the year (2020: loss was \$1.06 million). The net assets of the Company were \$101.6 million (2020: \$101.1 million). There was no revenue from gold mining sales in the period.

During the year, the Company raised \$2 million, confirming the continued support of investors and shareholders in the Charters Towers Gold Project.

The main asset of the Company is the Charters Towers Gold Project comprising the gold deposit and the major developed surface and underground infrastructure for the Central and Warrior/Imperial Mines.

This infrastructure includes granted Mining Leases, two underground mine accesses to over 200 vertical metres depth, buildings, power, water, and roads etc. The infrastructure owned by the Company is represented in the \$110 million capitalised Exploration, Evaluation and Development expenditure including the Development Property, Land, Buildings and Equipment.

In preparing the financial report for the year, the Board reviewed the values of assets (carrying amount) and in particular the Property, Plant and Equipment (PPE) comprised principally of the Charters Towers Gold Project assets.

- This review considered the value of assets by discounting estimated future cash flows using appropriate discount rates and other industry value measures.
- The Board considered the cash flows and assumptions used in calculations prepared by management and experts for material assets, bearing in mind their knowledge of the business, the assets, the environment in which the Company operates, previous transactions and the future prospects of the business.
- In all the material data used in the assessment, only the timing of the capital injection to advance the project needs to be completed. This does not materially alter the value and with current knowledge we expect that to be fulfilled.
- After considering various internal and external factors, the Board has determined that no further impairment is required.





As previously advised, major project funding discussions actively continued with potential strategic partners to expand Citigold's production-ready Charters Towers Gold Project. The Company has seen an increase in interest by potential funding partners with the relative strong gold price.

There was no dividend declared for the period.

## MINERALS RESOURCE AND ORE RESERVES

- 2020 Mineral Resources and Ore Reserves report released.
- Gold resources increase 27% to 14 million oz Inferred Mineral Resources and Probable Reserves remain unchanged.

The year saw the release of an updated technical report "Mineral Resources and Ore Reserves 2020" for the Charters Towers Gold Project.

This independent Technical Report has been prepared in accordance with the Joint Ore Reserves Committee Australasian Code for Reporting of Exploration Results, Mineral Resources and Ore Reserves 2012 ('the JORC Code').

The 189 pages Technical Report by the consultants is a comprehensive review and evaluation of the Project's geological gold deposit. The consultant's findings replace previously released reports with the "Mineral Resources and Ore Reserves 2020 for the Charters Towers Gold Project" (Gold Technical Report 2020).

JORC checklist of assessment and reporting criteria as required under the 2012 JORC code has also been included commencing on page 11 JORC CHECKLIST. No gold production or infill drilling was undertaken during the year. The critical assumptions and technical parameters underpinning the estimates continue to apply and have not materially changed.

## **GEOLOGY & EXPLORATION**

- Field exploration geochemical sampling programs during the year produced encouraging results.
- Potential for new undiscovered mineralised bodies to the north of Charters Towers.

Sample No. 74 is considered highly significant having a base metal and silver signature that more closely matches a Volcanogenic Massive Sulphide (VMS) deposit than the traditional Charters Towers style of mineralisation. The sample returned 10.15 g/t gold, 2.03% zinc, 0.8% lead, 0.07% copper and nearly an ounce to the tonne silver (29 g/t Ag).


The samples are all on Citigold's Exploration Permits and Mineral Development Licenses, and the majority of the anomalous rock float samples fall on or close to Citigold granted Mining Leases.

A series of stream sediment Bulk Cyanide Leach samples were taken over 84 sites together with rock float and sediment samples. Of the 82 rock float samples collected, 19 were below detection limit, 29 were considered anomalous (greater than 0.1 g/t Au) and of these, 16 were greater than 0.5 g/t Au. Eight samples were 1 g/t Au or higher.

However, three anomalous samples over 0.5 g/t Au were located at the northern extremity of the Exploration Permits, five to eight kilometres north of the centre of Charters Towers and returning gold values of 0.59, 0.51 and 0.83 g/t Au respectively. These are considered highly significant as the occurrence of rock float samples 5-8 Kms north of the city indicate that gold-bearing outcrops are shedding into creeks in an area not previously known to be mineralised. These three samples have highlighted new mineralisation with the potential for northern extensions of the known cross veins and new east-west lodes.

This highlights potential for the main NNW-SSE trending gold-bearing lode systems at Charters Towers to persist to the north of the city, and for the existence of undiscovered new east-west lodes parallel to the Brilliant, Day Dawn and Queen-Sunburst lodes. These samples were followed up in May and June 2021 with results pending as at the release of the annual report.

In addition, three high-value rock float samples were located south of the city. These samples returned high gold values of 15.3, 10.15 and 3.17 g/t Au respectively. One sample on MDL119 (15.3 g/t Au) had two previously-mapped gold occurrences (Perfect Cure and Queenslander) 300 metre to the east and one previously-mapped occurrence 600 metre to the southwest but this is in a different drainage basin and cannot be a source. The Little Red Bluff gold deposit lies at the head of the drainage basin in which Sample No. 6 is located, and this is a possible source.

Sample No. 74 is considered highly significant. It has a base metal and silver signature that more closely matches a Volcanogenic Massive Sulphide (VMS) deposit than the traditional Charters Towers style of mineralisation. The sample returned 2.03% zinc, 0.8% lead, 0.07% copper and nearly an ounce to the tonne silver (29 g/t Ag). It is located 200m northeast of the northeast corner of ML 10335 that covers the eastern extensions of the Imperial Mine lodes. There is no known mineralisation in the 1.5 kilometres drainage basin upstream of the float sample location. This sample may indicate potential for a VMS style of deposit in the drainage basin, similar to VMS mineralisation found to the south at Liontown and to the west at Thalanga.

on 20 April 2021, Citigold announced with the traditional wet season having finished, the 2021 exploration program had commenced.

During May and June 2021, an expanded program of sampling 74 additional sites was planned to infill the more broad sampled areas and to follow up on the earlier anomalies. As in the earlier program, three samples were planned to be taken at each site, totalling 222 samples from 74 sites.

During the year, no new exploration drilling was undertaken.

Normal regulatory compliance reporting for exploration, mine and environmental continued during the year.

## **CORPORATE GOVERNANCE**

The Board considers there to be a clear and positive relationship between the creation and delivery of long-term shareholder value and high-quality corporate governance. Accordingly, in pursuing its objective, the Board has committed to corporate governance arrangements that strive to foster the values of integrity, respect, trust and openness amongst and between the Board members, management, personnel, suppliers, and stakeholders.

Unless stated otherwise in this document, the Board's corporate governance arrangements comply with the recommendations of the ASX Corporate Governance Council as outlined in the 4th edition of the Corporate Governance Principles and Recommendations for the entire financial year ended 30 June 2021.

## SAFETY, HEALTH, COMMUNITY AND ENVIRONMENT RISK

Citigold is committed to creating and maintaining both a safe environment at the workplace and in the local community. There were no Lost Time Injuries or significant health issues during the period. The Company's Lost Time and Disabling Injury Frequency Rates (LTIFR and DIFR) remain at zero. During the year, the sites were maintained.

The Company's mine sites have been established so as to have the minimal land surface area thereby minimizing surface impact.

A review conducted by the Company indicates that by using renewable energy, electric-powered mobile machinery underground and repurposing of waste rocks into the community will minimise the Company's environmental footprint.

Covid-19 has impacted how businesses are run all over the world, including the focus on keeping workers safe. The company is monitoring the work environment to ensure that personnel are kept safe.

Citigold is exposed to a range of economic, environmental and social sustainability risks faced by all other mining industry companies in an open economy.

The Company has a long-established practice of operating in harmony with the community and the local environment.

#### REHABILITATION

Citigold's project team reviewed the previous vegetation rehabilitation work carried out at Warrior and Stockholm involving placing topsoil and sowing grass seeds. The progress of vegetation re-generation over time and wildlife habitation is very pleasing.

The Central underground access area was once a very disturbed historic mining area that was rehabilitated to the attractive grasslands that largely surrounds the mine site's environmental compound.



## INDIGENOUS ENGAGEMENT

Citigold has a long history of contributing to the recognition of indigenous achievements. After all it was the young indigenous Australian 'Jupiter' who in 1871, as part of the discovery prospecting team, is credited with discovering gold that led to the building of Charters Towers.

Citigold's recognition of Jupiter included commissioning two paintings in 1997 and 1999. The first depicting Jupiter as an elderly statesman of Charters Towers, and the second is an artists impression of the discovery of gold in Mosman Creek by Jupiter and the prospecting team. The first painting hangs in Charters Towers at 'The World Theatre' foyer, once being the original banking chamber for the Bank of NSW, and the second 'discovery' painting until recent times hung in the reception of the Jupiter's Casino in Townsville.



## 7. REVIEW OF OPERATIONS

During the 2021 Financial Year, the Charters Towers Gold Project remained the Company's prime focus. The Project comprises of the very large gold deposits, as set out in the Technical Report: Mineral Resources and Ore Reserves 2020 (See ASX announcement dated 9 December 2020 Mineral Resources and Ore Reserves 2020). Citigold's Mineral Resources and Ore Reserves for the overall Gold Project are reported in accordance with the Australiasian JORC Reporting Code 2012. Mineral Resources and Ore Reserves were updated during the financial year. The critical assumptions and technical parameters underpinning the estimates continue to apply and have not materially changed. There was no gold production during the year with all the project sites and assets being maintained in care and maintenance ready for recommencement of mining operations.

The Company does not require additional mine acquisitions to recommence and sustain long term gold production. Citigold has already invested over \$200 million in acquiring the gold deposit, developing the infrastructure and mines at Charters Towers. Gold production test mining operations have produced over 100,000 ounces of gold.

The past year has seen the Company further refine its development strategy, and innovation plans, that aim to optimise the assets at Charters Towers and become an ultra-low cost gold producer. Additionally, these savings will include reducing the environmental surface footprint of the mine as it moves back into larger scale gold production.

The Charters Towers Project still remains one of Australia's largest high-grade pure gold deposits.

## 8. LIKELY DEVELOPMENTS AND EXPECTED RESULTS OF OPERATIONS

Likely developments in the operations of the consolidated entity are:

- a. the continuation of exploration activity aimed at increasing resources and reserves,
- b. the continuation of mining activity at Charters Towers.

Additional comments on expected results are included in the Review of Operations.

- Level 1 incident major non-compliance with regulatory requirements resulting in potential political outcry and significant environmental damage of both a long and short-term nature.
- Level 2 incident significant non-compliance resulting in regulatory action, however, environmental damage is only of a short term nature.
- Level 3 incident minor non-compliance, however, regulatory authority may be notified.
- Level 4 incident non-compliance with internal policies and procedures. The incident is contained on site.

The framework aligns executive reward with the achievement of strategic objectives and the creation of value for shareholders and conforms to the market best practice for delivery of reward. The Board of Directors ('the Board') ensures that executive reward satisfies the following key criteria for good reward governance practices:

- · competitiveness and reasonableness
- acceptability to shareholders
- performance linkage / alignment of executive compensation
- transparency

## 2021 Annual Report

While the Board has overall responsibility for the executive structure and outcomes, it has appointed a Nomination and Remuneration Committee for advice and makes recommendations on remuneration matters.

The performance of the consolidated entity and the company depends on the quality and dedication of its directors and executives. The remuneration philosophy is to attract, motivate and retain high performance, dedicated and high quality personnel.

The Remuneration Committee annually considers the appropriate levels and structure of remuneration for Directors and Key Management Personnel relative to the Company's circumstances, size and nature of business, as well as company performance. This is done by reference to independent data and advice.

The Company competes for labour in the broader resources industry. In selecting, retaining and remunerating directors and executives the committee considers the appropriateness, taking into account the corporate and operational regulatory environment that a mining enterprise operates on these days in Australia that places substantial and ever increasing burdens of responsibility upon these officers of the Company in addition to the usual business performance.

Reward structures are transparent and align with shareholders' interests by:

- being market competitive to attract and retain high calibre individuals motivated and skilled in the business of the Company;
- recognising the contribution of each senior executive to the continued growth and success of the Company;
- encouraging, recognising and rewarding high individual performance; and
- ensuring that long term incentives are based on total shareholder return outperformance over a period of three years.

In accordance with best practice corporate governance, the structures of non-executive directors and executive remunerations are separate.

#### Non-Executive Directors Remuneration

Non-executive directors are paid fixed fees. In addition, Non-Executive directors may also be remunerated for additional service, for example, if they take consulting work on behalf of the company outside the scope of their normal Directors duties. Fees and payments to non-executive Directors are set to attract individuals of appropriate calibre and reflect the demands which are made on, and the responsibilities of, the Directors. Non-Executive Directors' fees and payments are reviewed annually by the Remuneration Committee and determined based on comparative roles in the external market.

In order to maintain their independence and impartiality, the fees paid to Non-Executive Directors are not linked to the performance of the Company. Non-Executive Directors have no involvement in the day to day management of the Company.

ASX listing rules require that the aggregate Non-Executive Directors remuneration shall be determined periodically by a general meeting. The most recent determination was at the Annual General Meeting held on 17 November 2010, where the shareholders approved an aggregate remuneration of \$400,000.

The Company remunerates its Non-Executive Directors \$60,000 pa board fees and \$5,000 pa per committee fees. The Committee Chairperson receives \$15,000 pa per committee. Directors generally have 3 year term and maybe re-elected.

## **Executive Remuneration**

The consolidated entity and company aims to reward executives with a level and mix of remuneration based on their position and responsibility, which is both fixed and variable.

The executive remuneration and reward may consist of the following

- Fixed remuneration
- Variable performance incentives
  - Short term incentives
  - Long term incentives

The combination of these comprises the executive's total remuneration.

## Fixed Remuneration

Fixed remuneration consisting of either fee or base salary, superannuation, long service leave and non-monetary benefits are reviewed annually by the Remuneration Committee, based on individual and business unit performance, the overall performance of the consolidated entity and comparable market remunerations.

Executives can receive their fixed fee or remuneration in the form of cash or other fringe benefits (for example motor vehicle benefits) where it does not create any additional costs to the consolidated entity and adds additional value to the executive.



## Variable Performance Incentives

#### Short-Term Incentives

The short-term incentive program is designed to align the targets of the business units with the targets of those executives in charge of meeting those targets and to improve the company's short term and long term performance. These incentives are meant to reward executives only when performance targets are met to increase shareholders value. They are granted to executives based on individual contribution to profit, production costs, leadership contribution and safety outcomes. Short-term incentives are currently paid in cash. No short-term incentives were paid during the reporting period.

## Long-Term Incentives

The long-term incentive include performance rights or share-based payments. No options were issued or exercised by any executive during the reporting period. No long-term incentives were paid during the reporting period. The Remuneration Committee may revisit the long-term equity-linked performance incentives specifically for executives during the year ending 30 June 2021.

The majority of bonus and incentive payments are at the discretion of the Nomination and Remuneration Committees.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2021

The financial report of Citigold Corporation Limited for the year ended 30 June 2021 covers Citigold Corporation Limited as an individual entity as well as the consolidated entity consisting of Citigold Corporation Limited and its subsidiaries as required by the Corporations Act 2001.

Citigold Corporation Limited is a company limited by shares incorporated in Australia whose shares is publicly traded on the ASX Limited.

## 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following significant accounting policies have been adopted in the preparation and presentation of the yearly financial report. The financial reports include separate financial statements for Citigold Corporation Limited as an individual entity and the consolidated entity consisting of Citigold Corporation Limited and its subsidiaries.

## **BASIS OF PREPARATION**

The financial report is a general purpose financial report, which has been prepared in accordance with Australian equivalents to International Financial Reporting Standards (AIFRS), other authoritative pronouncements of the Australian Accounting Standards Board and the Corporations Act 2001.

The financial report has been prepared on the basis of historical cost. Cost is based on the fair values of the consideration given in exchange for assets.

## A) BASIS OF CONSOLIDATION

The financial report of the Citigold Corporation Group ("the consolidated entity") includes the consolidation of Citigold Corporation Limited and its respective subsidiaries. Subsidiaries are entities controlled by the parent entity. Control exists where the parent entity has the power to govern the financial and operating policies of an entity so as to obtain benefits from its activities. Subsidiaries are included in the consolidated financial report from the date control commences until the date control ceases. The effects of all transactions between entities within the Citigold Corporation Group have been eliminated.

Intercompany transactions, balances and unrealised gains on transactions between Group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of the impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Where the Citigold Corporation Group's interest is less than 100 percent, the interest attributable to outside shareholders is reflected in non-controlling interests. Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of profit or loss and other comprehensive income and statement of financial position respectively.

## **B) FOREIGN CURRENCY TRANSLATION**

The results and financial position of each entity are expressed in Australian dollars, which are the functional currency of Citigold Corporation Limited and the presentation currency for the consolidated financial statements.

In preparing the financial statements of individual entities, transactions in currencies other than the entity's functional currency are recorded at the rates of exchange prevailing on the dates of transactions. At balance date, monetary items denominated in foreign currencies are retranslated at the rates prevailing at the balance date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when fair value is determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

## C) LOAN AND BORROWINGS

Loan and borrowings are initially recognised at fair value, net of transaction costs incurred. Borrowings are subsequently measured at amortised cost, less any impairment. Any difference between the proceeds (net of transaction costs) and the redemption amount is recognised in the statement of profit or loss and other comprehensive income over the period of the loans and borrowings using the effective interest method.

## D) CASH AND CASH EQUIVALENTS

For the purposes of the statement of cash flow, cash and cash equivalents including, cash on hand and at bank, deposits held at call with financial institutions, other short term, highly liquid investments with maturities of three months or less, that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

## **E) TRADE AND OTHER RECEIVABLES**

Trade receivables are recognised at original invoice amounts less an allowance for uncollectible amounts and have normal repayment terms or longer from time to time. Collectability of trade receivables is assessed on an ongoing basis. Debts which are known to be uncollectible are written off.



## F) EMPLOYEE BENEFITS

## 1) Provision for wages and salaries, annual leave and long service leave

Provision is made for the benefits accruing to employees in respect of wages and salaries, annual leave and long service leave when it is probable that the settlement will be required and they are capable of being measured reliably.

Provisions made in respect of employee benefits expected to be settled within 12 months are measured at their nominal values using the remuneration rate expected to apply at the time of settlement.

Provisions made in respect of employee benefits which are not expected to be settled within 12 months are measured as the present value of the estimated future cash outflows to be made by the consolidated entity in respect of services provided by employees up to reporting date.

The liability for long service leave is recognised in the provision for employee benefits and measured as the present value of expected future payments to be made in respect of services provided by employees up to the reporting date using the projected unit credit method. Consideration is given to expected future wage and salary levels, experience of employee departures and periods of service. Expected future payments are discounted using market yields at the reporting date on national government bonds with terms to maturity and currency that match, as closely as possible, the estimated future cash flows.

## 2) Share-based payment transactions

The fair value of any options granted under any share option plan is recognised as an employee benefit expense with a corresponding increase in equity (share option reserve). The fair value is measured at grant date and recognised over the period during which the employees become unconditionally entitled to the options. Fair value is determined by using the Black-Scholes option pricing model. In determining fair value, no account is taken of any performance conditions other than those related to the share price of the Company ("market conditions"). The cumulative expense recognised between grant date and vesting date is adjusted to reflect the director's best estimate of the number of options that will ultimately vest because of internal conditions of the options, such as the employees having to remain with the company until vesting date, or such that employees are required to meet production targets. No expense is recognised for options that do not ultimately vest because internal conditions were not met. An expense is still recognised for options that do not ultimately vest because a market condition was not met.

No employee share option plan currently exists.

## G) EXPLORATION, EVALUATION AND DEVELOPMENT EXPENDITURE

Exploration and evaluation costs are written off in the year they are incurred, apart from acquisition costs which are carried forward where right of tenure of the area of interest is current and the expenditure is expected to be recouped through sale or successful development and exploration of the area of interest or where exploration and evaluation activities in the area of interest have not at the reporting date reached a stage which permits a reasonable assessment of the existence or otherwise of economically recoverable reserves, and active and significant operations in, or in relation to, the area of interest are continuing.

Development expenditure is capitalised in the year it is incurred.

## H) IMPAIRMENT OF ASSETS

At each reporting date, the consolidated entity reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). Where the asset does not generate cash flows that are independent from other assets, the consolidated entity estimates the recoverable amount of the cash-generating unit to which the asset belongs.

The recoverable amount is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

## I) TAXATION

#### Current tax

Current tax is the expected tax payable on the taxable income for the period, using tax rates and tax laws that have been enacted or substantively enacted by the reporting date. Current tax for current and prior periods is recognised as a liability (or asset) to the extent that it is unpaid (or refundable).

## Deferred Tax

Deferred tax is accounted for using the comprehensive statement of financial position liability method in respect of temporary differences arising from differences between the carrying amount of the assets and liabilities in the financial statements and the corresponding tax base of those items.

Deferred tax liabilities are recognised for all taxable temporary differences. Deferred tax assets are recognised to the extent that it is probable that sufficient taxable amounts will be available against which deductible temporary differences or the unused tax losses can be utilised.

## 2021 Annual Report

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period(s) when the assets and liabilities, giving rise to them are realised or settled, based on tax rates and tax laws that have been enacted by the reporting date.

Current and deferred tax for the period is recognised as an expense or income in the statement of profit or loss and other comprehensive income, except when it relates to items credited or debited directly to equity, in which case the deferred tax is recognised directly in equity.

## Tax consolidation

The parent entity company and all its wholly-owned Australian resident entities are part of a tax consolidated group under the Australian taxation law. Citigold Corporation Limited is the head entity in the tax-consolidated group.

#### Goods and services tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except for receivables and payables which are recognised inclusive of GST.

The net amount of GST recoverable from, or payable to, the taxation authority is included as part of receivables or payables.

Cash flows are included in the statement of cash flow on a gross basis. The GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

## J) INVENTORIES

Gold in solution form and the ore is physically measured or estimated and valued at the lower of cost and net realisable value. Costs include direct costs and appropriate portion of fixed and variable production costs.

Consumables are valued at the lower of cost and net realisable value. Costs are assigned to inventory on hand using the first in first out method. Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

## **K) LEASED ASSETS**

The Group has adopted AASB 16 'Leases' (AASB 16). The Standard eliminates the classifications of operating leases and finance leases. Except for short-term leases of 12 months or less and leases of low-value assets (such as personal computers and small office furniture), right-of-use assets and corresponding lease liabilities are recognised in the statement of financial position.

## Right-of-use assets

The Group recognises right-of-use assets at the commencement date of the lease (i.e. the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received.

Right-of-use assets are depreciated on a straight-line basis over the unexpired period of the lease or the estimated useful life of the asset, whichever is the shorter. Where the Group expects to obtain ownership of the leased asset at the end of the lease term, the depreciation is over its estimated useful life.

#### Lease liabilities

A lease liability is recognised at the commencement date of a lease. The lease liability is initially recognised at the present value of the lease payments to be made over the term of the lease, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Group's incremental borrowing rate. Lease payments comprise of fixed payments less any lease incentives receivable, variable lease payments that depend on an index or a rate, amounts expected to be paid under residual value guarantees, exercise price of a purchase option when the exercise of the option is reasonably certain to occur, and any anticipated termination penalties. The variable lease payments that do not depend on an index or a rate are expensed in the period in which they are incurred.

At the reporting date, the company had no leases.

## L) FINANCIAL ASSETS

Financial assets are initially measured at fair value. Transaction costs are included as part of the initial measurement, except for financial assets at fair value through profit or loss. Such assets are subsequently measured at either amortised cost or fair value depending on their classification. Classification is determined based on both the business model within which such assets are held and the contractual cash flow characteristics of the financial asset unless an accounting mismatch is being avoided

## Impairment of Financial Assets

Financial assets, other than those at fair value through profit and loss, are assessed for indicators of impairment at each balance date. Financial assets are impaired where there is objective evidence that as a result of one or more events that occurred after initial recognition of the financial asset, the estimated future cash flows of the investment have been impacted.

For equity instruments, including listed or unlisted shares, objective evidence of impairment includes information about



significant changes with an adverse effect that have taken place in technological, market, economic or legal environment in which the issuer operates, and indicates that the cost of the investment in the equity instrument may not be recovered. Where there is a significant or prolonged decline in the fair value of an available for sale financial asset (which constitutes objective evidence of impairment), the full amount of the impairment, including any amount previously charged to equity, is recognised in the statement of profit or loss and other comprehensive income

In respect of available for sale equity instruments, any subsequent increase in fair value after an impairment loss is recognised directly in equity.

#### M) TRADE AND OTHER PAYABLES

Trade payables and other accounts payable are recognised when entities in the consolidated entity become obliged to make future payments resulting from the purchase of goods and services. These amounts are unsecured and have normal credit terms or longer from time to time.

## N) PROPERTY, PLANT AND EQUIPMENT

Development Properties are measured at cost less accumulated amortisation.

Freehold land is not depreciated.

All other plant and equipment are stated at historical cost less depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying value or recognised as a separate asset only when it is probable that a future economic benefit associated with the item will flow to the Company and the cost can be measured reliably. All other repairs and maintenance are charged to the statement of profit or loss and other comprehensive income during the reporting period in which they are incurred.

## Depreciation of property, plant and equipment

The carrying amounts of property, plant and equipment (including the original capital expenditure and any subsequent capital expenditure) are depreciated to their residual value over the useful economic life of the specific assets concerned or the life of the mine or lease, if shorter. The rates vary between 4% and 40%.

Depreciation is calculated on a straight line basis so as to write off the net cost or other re-valued amount of each asset over its expected useful life to its estimated residual value. Leasehold improvements are depreciated over the period of the lease or estimated useful life, whichever is the shorter, using the straight line method.

Depreciation rates and methods shall be reviewed at least annually and, where changed, shall be accounted for as a change in accounting estimate. Where depreciation rates or methods are changed, the net written down value of the asset is depreciated from the date of the change in accordance with the new depreciation rate or method. Depreciation recognised in prior financial years shall not be changed, that is, the change in depreciation rate or method shall be accounted for on a 'prospective' basis.

## O) PROVISION FOR RESTORATION AND REHABILITATION

Entities in the consolidated entity are generally required to decommission and rehabilitate mine and processing sites at the end of their producing lives to a condition consistent with its Plan of Operations, environmental policies and acceptable to the relevant authorities. The expected cost of any approved decommissioning or rehabilitation programme is provided when the related environmental disturbance occurs, based on the interpretation of environmental and regulatory requirements.

Where there is a change in the expected decommissioning and restoration costs, an adjustment is recorded against the carrying value of the provision and any related asset, and the effect is then recognised in the statement of profit or loss and other comprehensive income in the year incurred.

The provisions referred to above do not include any amounts related to remediation costs associated with unforeseen circumstances. Such costs are recognised when environmental contamination as a result of oil and chemical spills or other unforeseen events gives rise to a loss which is probable and reliably estimable. The cost of other activities to prevent and control pollution is charged to the statement of profit or loss and other comprehensive income as incurred.

#### P) CONTRIBUTED EQUITY

Ordinary shares are classified as equity.

Costs directly attributable to the issue of new shares or options are shown as a deduction from the equity proceeds, net of any income tax benefit. Costs directly attributable to the issue of new shares or options associated with the acquisition of a business are included as part of the purchase consideration.

# **Q) EARNINGS PER SHARE**

#### 1) Basic earnings per share

Basic earnings per share are calculated by dividing the profit attributable to members of the Group, adjusted for the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares during the year. The weighted average number of issued shares outstanding during the financial year does not include shares issued as part of any Employee Share Option Plan that are treated as in-substance options.

#### 2) Diluted Earnings per share

Earnings used to calculate diluted earnings per share are calculated by adjusting the basic earnings by the after-tax effect of dividends and interest associated with dilutive potential ordinary shares. The weighted average number of shares used is adjusted for the weighted average number of shares assumed to have been issued for no consideration in relation to dilutive potential ordinary shares.

#### **R) REVENUE RECOGNITION**

The Group recognises revenue as follows:

Revenue from contracts with customers

Revenue is recognised at an amount that reflects the consideration to which the Group is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the Group: identifies the contract with a customer; identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised.

Variable consideration within the transaction price, if any, reflects concessions provided to the customer such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are initially recognised as deferred revenue in the form of a separate refund liability.

#### Gold Sales

Revenue from the sale of goods is recognised at the point in time when the customer obtains control of the goods and the metal content of the goods delivered is determined.

## Other income

Other income is recognised when it is received or right to received payment is established.

#### S) GOING CONCERN

In consideration of the management's use of the going concern basis of reporting, a distinction is made between the Company and consolidated entity's ability to pay its operating debts as and when they fall due within the next 12 months and the Company's ability to exploit its tenements and other factors that may impact on the Company continuing as a going concern.

#### Operating expenditure

The Company's cash flow forecast includes management's estimates of operating expenses for the next 12 months of approximately \$1.4million.

The Company had a cash balance at reporting date of \$432,029, capital raising of \$2 million and no gold sales occurred during the period. The Company has a track record of being able to raise sufficient cash through capital placements and or assets sales to pay its operating expenses as and when they fall due. The Company has a long and proven record of successfully raising capital and loan funds even in the recent difficult Covid-19 times.

With strong gold price and strong demand for gold and gold assets, the Covid-19 pandemic is unlikely to post a material impact on the company ability to raise capital when required. Moreover, with the company operating in a low cost environment and have the ability to further reduce expenditure. The company is well placed to navigate through this current difficult business environment.

The Group's ability to continue as a going concern is reliant upon the Group's ability to recycle its debt obligations through share placements and share purchase plans as well as through operating activities.

At 30 June 2021, the Group has capitalised mining tenement costs of \$130.35M. AASB 136, 'Impairment of Assets' requires that the recoverable amount of an asset, or cash generating unit to which it belongs, be determined whenever an indicator of impairment exists.

An indicator of impairment exists as the current market capitalisation is \$28.3M which is below the net assets of the Group of \$101.6M.

The Group's assessment of the recoverable amount of its mining tenements was a key audit matter because the carrying value of the assets are material to the financial statements and management's assessment of recoverable amounts incorporated significant internal and external judgments and assumptions including commodity prices, available reserves, residual values and discount rates.

# How our audit addressed the key audit matter Our procedures included, amongst others:

- Review of the independent valuation report dated 9
   August 2021 prepared by Global Resources &
   Infrastructure Pty Limited stating a substantial higher
   valuation than the current valuation in the financial
   statements.
- We have not solely relied upon the independent valuation report and noting the indication of impairment, we have performed additional scrutiny and testing of the Group's Discounted Cash Flow that supports the carrying amount disclosed in the financial statements.
- We confirmed that the external expert engaged by management to provide the independent valuation report was appropriately experienced and qualified.
- We tested management's key assumptions and estimates used to determine the recoverable amount of its assets, including those related to forecast commodity prices and revenue costs, discounted rates and estimated residual values.
- We have confirmed that mineral resources have not materially changed from last financial year, other than as announced to the ASX.
- We checked the mathematical accuracy of the cash flow models, testing inputs from valuation reports produced, as well as external inputs, including spot and forecast prices for the reserves at the reporting date.
- With respect to cost inputs, we have confirmed that the cash flow model has been updated to have regard to the sale of processing plant and equipment.

At 30 June 2021, the Group had \$617K in non-current borrowings. Included in this is a loan from related parties of \$193k.


