## DELTA DRONE INTERNATIONAL COMPLETES ACQUISITION OF ARVISTA ACHIEVING KEY EXPANSION MILESTONE

- Arvista acquisition complete and to commence trading as a Delta Drone International subsidiary as of 1 September 2021
