Think Childcare Group (ASX Code: TNK) Results of Meetings

Think Childcare Group (ASX:TNK) ("**Think Group**") is pleased to announce that at the meetings held earlier today, Think Group Securityholders voted to approve both the TNK Scheme and the TND Scheme, and voted in favour of all of the General Meeting Resolutions, as referred to in the Explanatory Booklet dated 19 August 2021.

Defined terms in this announcement have the meanings given to them in the Explanatory Booklet.

Voting results for the Meetings

For the purpose of ASX Listing Rule 3.13.2 and subsections 251AA(1) and (2) of the *Corporations Act 2001* (Cth) (**Act**):

- the TNK Scheme Resolution was passed by the requisite majorities of TNK Shareholders with:
 - 97.55% of TNK Shareholders (other than the MGE Entities) present and voting (either in person or by proxy) in favour of the resolution; and
 - 99.85% of votes cast by TNK Shareholders (other than the MGE Entities) present and voting (either in person or by proxy) in favour of the resolution.
- the TND Scheme Resolution was passed by the requisite majorities of TND Shareholders with:
 - 97.55% of TND Shareholders (other than the MGE Entities) present and voting (either in person or by proxy) in favour of the resolution; and
 - 99.85% of votes cast by TND Shareholders (other than the MGE Entities) present and voting (either in person or by proxy) in favour of the resolution.

- each of the General Meeting Resolutions were passed by the requisite majorities of Think Group Securityholders with:
 - 99.85% of votes cast by Think Group Securityholders (other than the MGE Entities) present and voting (either in person or by proxy) in favour of the MGE Acquisition Resolution;
 - 99.89% of votes cast by Think Group Securityholders present and voting (either in person or by proxy) in favour of the Unstapling Resolution; and
 - 99.89% of votes cast by TNK Shareholders present and voting (either in person or by proxy) in favour of the Appointor Structure Approval Resolution.

The poll report for each of the Meetings by the Returning Officer appointed by Think Group is attached.

Next steps

Think Group will now apply to the Federal Court of Australia for approval of the TNK Scheme and the TND Scheme. The Court hearing is scheduled to commence at 9.00am on Wednesday, 6 October 2021 as a virtual (online only) hearing. Independent Securityholders have the right to appear and be heard at that Court hearing and may oppose the approval of the Schemes at that Court hearing. Independent Securityholders wishing to oppose the approval of the Schemes by the Court at the Court hearing must file with the Court, and serve on Think Group, a notice of appearance in the prescribed form, together with any affidavit on which they wish to rely at the hearing.
