Diamond Drilling to Commence at Douglas Canyon Gold Project in Nevada

Highlights

- Maiden diamond drilling program at the high-grade Douglas Canyon Gold Project scheduled to commence this month
- Drilling planned to consist of four hole, 1,000m campaign;
 - Initial two holes targeting known near-surface mineralised structures; and
 - Additional two holes to be positioned to test down dip depth extensions
- Drilling will target outcropping high-grade gold-silver epithermal veins, with previously reported surface outcrop samples including:
 - 18.0g/t Au + 398g/t Ag
 - 16.2g/t Au + 495g/t Ag
 - 14.0g/t Au + 423g/t Ag
- Project is located in the prolific Walker Lane Gold-Silver District in southern Nevada

Oar Resources Limited ("Oar" or "the Company", ASX: OAR) is pleased to announce detailed plans for the commencement of the first phase of drilling at the Company's 100% owned Douglas Canyon Gold-Silver Project ("the Project") in the prolific Walker Lane Gold-Silver district of southern Nevada, USA (Figure 1).

Oar has secured drilling and geological contractors to undertake the Company's maiden drilling program at the high-grade Douglas Canyon Project, and drilling is scheduled to commence this month.

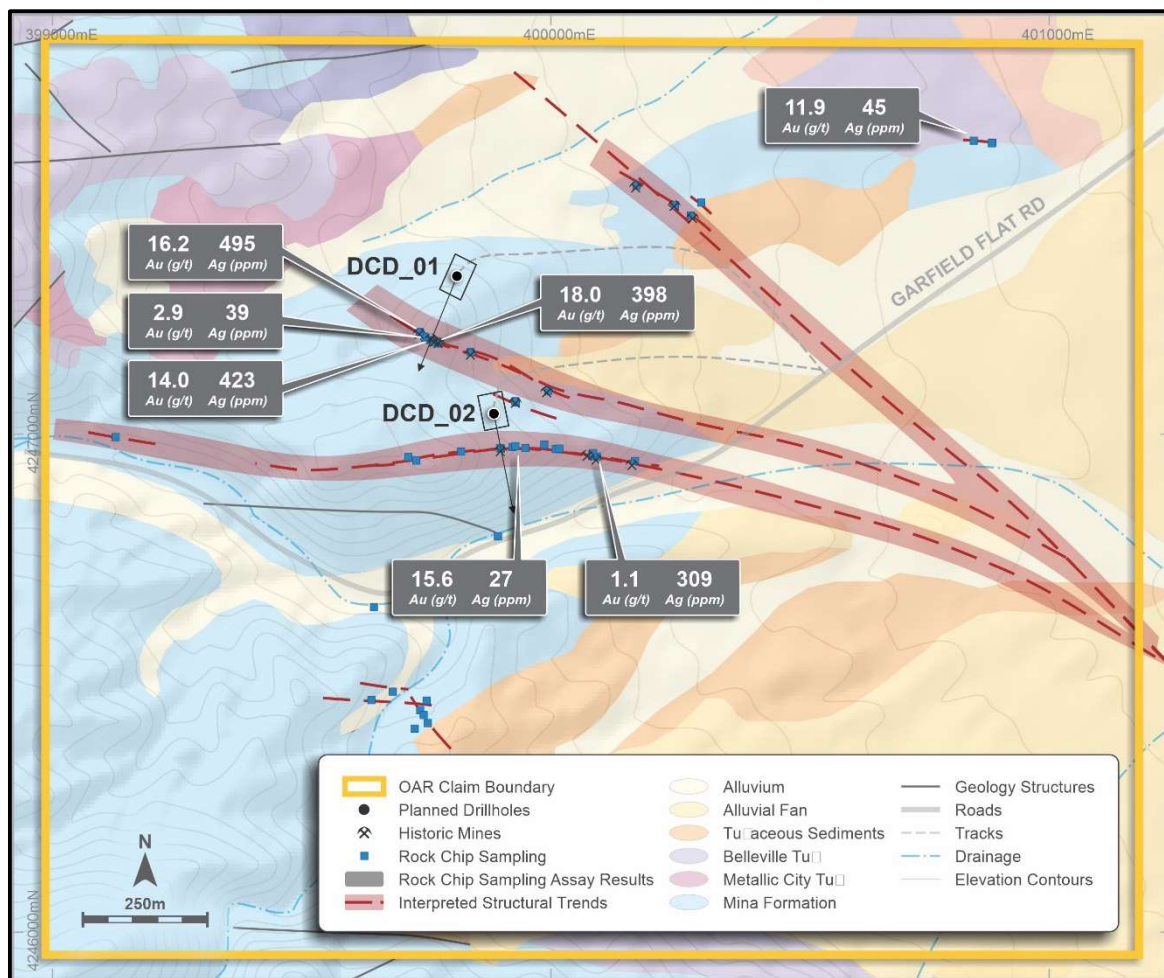


Figure 2: Douglas Canyon Project showing Gold and Silver Sampling Resultsⁱⁱⁱ (g/t Au, ppm Ag) and Location of Proposed Stage One Diamond Core Holes

Drilling will initially comprise up to four diamond drill holes for a total of approximately 1,000m of HQ drill core to test outcropping high-grade gold and silver mineralisation, contained in shear hosted epithermal quartz veining (Figure 2). Previously reported outcrop sampling of these veins has returned exceptionally high grades including; 18.0 g/t Au, 398ppm Ag and 16.2 g/t Au, 495ppm Ag¹.

The Company proposes to drill an initial two holes, with an additional two holes to be positioned, based on the observations from logging of the first two holes.

The initial two holes are expected to take 4-5 weeks to complete, and results will be released as they become available.

OAR's General Manager Geology, Tony Greenaway Commented: "We are very excited to have the diamond drilling about to get underway at our high-grade Douglas Canyon gold project in Nevada. Drill testing of the stand-out targets has been a high priority for Oar, given the exceptional results from our initial outcrop sampling, and the project's location in the prolific Walker Lane district of Nevada, where there is currently a significant amount of exploration activity occurring."

"We have a highly experienced contract geology team on the ground in Nevada to manage this drilling campaign, which gives the Company a high degree of confidence that we will achieve our on-ground goals. With a total of four holes and 1,000m of drill core planned, these exceptional targets will be given a thorough test and we will be eagerly awaiting the first results and observations from the core logging."

About the Douglas Canyon District

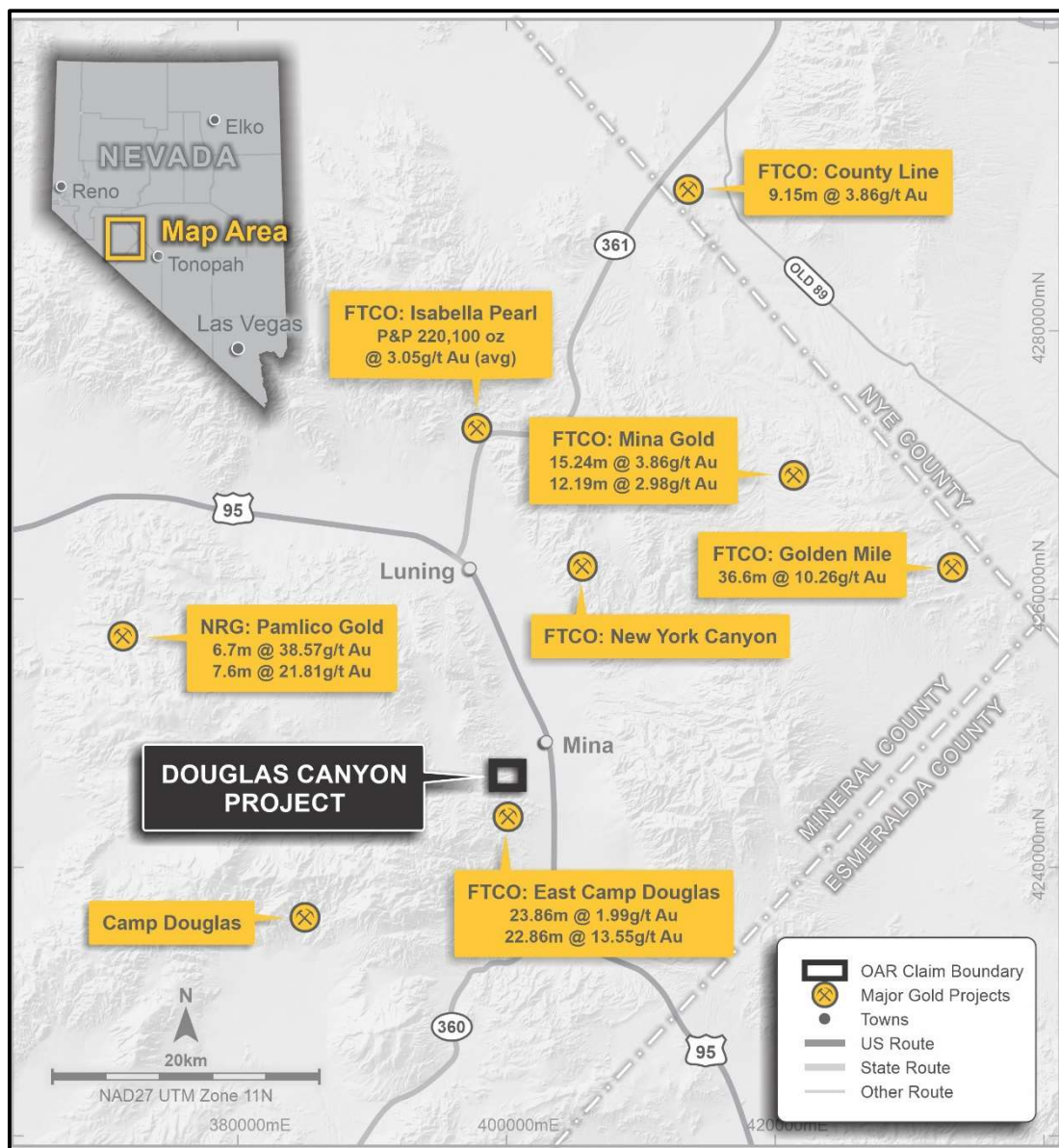


Figure 3: Douglas Canyon Project area showing, Project locations and recent exploration results by Fortitude Gold Corporation (FTCO) ⁱⁱⁱ and New Range Gold Corporation (NRG) ^{iv}

The Douglas Canyon project is located in the Camp David/Mina district in Southern Nevada which hosts numerous high-grade gold-silver epithermal projects. The area in the immediate vicinity of Oar's Douglas Canyon Project is a major focus of exploration, with Fortitude Gold Corporation (OTC QB: FTCO) ("Fortitude"), commencing production as recently as 2019, at its Isabella Pearl Gold mine located just 24 km to the northwest of Douglas Canyon (Figure 3). The Isabella Pearl mine has an estimated reserve of **1.28Mt @ 3.88g/t Au (159,000oz Au)ⁱⁱⁱ**, with Fortitude targeting annual production of 40,000-45,000oz Au.

Other recent exploration success by Fortitude in the area includes the Mina Gold Project, with drill intersections of **15.24m @ 3.86g/t goldⁱⁱⁱ** from surface, and the East Camp Douglas Project adjacent and south of Oar's Douglas Canyon Project, which has returned intersections, including **22.86m @ 13.55g/t gold from 4.6mⁱⁱⁱ** (Figure 3).

Gold mineralisation in the district is hosted in northwest trending shear hosted epithermal quartz veins similar to those mapped at surface at Oar's Douglas Canyon Project.
