## Spectur signs supply agreement with Australia Tower Network Pty Ltd

### Highlights

- Spectur signs a contract with Australia Tower Network Pty Ltd (ATN) leveraging the recent agreement with Singtel Optus Pty Ltd
- Signing of the agreement mitigates any potential customer risk stemming from Optus' sale of 70% of ATN to AustralianSuper

**Friday 24 December 2021:** Solar security, sensing and visual AI solutions and platforms company Spectur Limited (ASX: SP3) (**Spectur** or the **Company**) is pleased to announce the signing of an agreement (**Agreement**) between Optus, Spectur and Australia Tower Network Pty Ltd (**ATN**). This is further to the Company's ASX announcement of 18 November 2021, "\$1.07m Contract to provide Security Solutions to Optus."

This Agreement leverages off the recently concluded Master Services Agreement, (**MSA**) (Base terms and Goods & Services Module) signed with Singapore Telecommunications Limited (**Singtel**), in November 2021 and associated Statement of Works (**SoW**) that operates within the Singtel MSA.

Optus' parent company Singtel, which owns ATN, sold 70% of ATN to AusSuper and retained a 30% stake. ATN comprises 2,312 mobile network towers and rooftop sites across Australia. As part of the share sale, Optus will continue to have access to the ATN sites through long-term licences.

The Agreement with ATN allows ATN to issue new orders with Spectur. The SoW involves the provision of Spectur solar powered security hardware, field and monitoring services, and software subscriptions suitable for security applications on remote assets across Australia.

Signing this Agreement was an important step for Spectur because, as a result of the share sale, ATN is now not a related body corporate of Optus so the existing agreement with Optus cannot be used by ATN.

Spectur Managing Director, Gerard Dyson, said:

*"Spectur is very pleased to provide ongoing and extended services to core Optus assets and also now to Australia Tower Network Pty Ltd. Our solutions substantially reduce risk for key items of critical infrastructure and we are pleased to extend our offering in this way. We look forward to expanding these services to other owners of critical infrastructure and utilities in the future."*
