## Block, Inc. (formerly, Square, Inc.) (ASX: SQ2) – Admission and Quotation - Foreign Exempt Listing, Deferred Settlement Trading

### Description

Block, Inc. (formerly, Square, Inc.) ('SQ2'), a foreign company registered in the United States of America, was admitted to the Official List of ASX as an ASX Foreign Exempt Listing on Wednesday, 19 January 2022. Following completion of all necessary conditions to a proposed scheme of arrangement ('Scheme'), SQ2, through its wholly owned subsidiary, Lanai (AU) 2 Pty Ltd ('Lanai'), will acquire all of the issued share capital of Afterpay Limited ('APT').

Eligible APT Scheme shareholders that are on the APT share register on the record date will have their APT ordinary shares acquired in exchange for:

- 0.375 shares of SQ2 Class A common stock; or
- 0.375 CHESS Depositary Interests ('SQ2 CDIs') representing ownership interests in shares of SQ2 Class A common stock.

As an ASX Foreign Exempt Listing, SQ2 is primarily regulated by the listing rules of its home exchange (being the New York Stock Exchange) and is exempt from complying with most of ASX's Listing Rules.

Official Quotation of New SQ2 CDIs representing shares of SQ2 Class A common stock at a ratio of 1 for 1 is expected to commence at 11:00am (AEDT) on Thursday, 20 January 2022, initially on a **deferred settlement basis**.

SQ2 did not raise any capital in conjunction with its listing on ASX.
