

## ASX Announcement

### Quarterly Activities Report and Appendix 4C for December 2021

- **Despite the lockdown in NZ, positive revenues from the Hamilton Hotel continued to be achieved in Q2 of FY 2022.**
- **Rigorous efforts to control operational costs also assisted to offset the pandemic-related loss of retail revenue**
- **Innlanz is exploring potential opportunities to diversify and grow revenue and to increase its productive assets**

**SYDNEY, AUSTRALIA – 31 January 2022** - [Innlanz Limited](#) (ASX: INL) (“Innlanz” or the “Company”), is pleased to provide an update on its quarterly results for the period ended 31 December 2021. A copy of the Appendix 4C -Quarterly Cash Flow Report is attached.

The Company’s total cash position at 31 December was \$1.77m, down by \$697k from the previous quarter.

The Heartland Ambassador Hamilton Hotel finished with an occupancy level of 44.3% and ADR (average daily rate) of \$137.00 which grew approximately by \$7.00 total in comparison same period previous year. Thus, the hotel reached a total revenue of \$690K in the first half of the year. This result exceeds expectations despite the Covid 19 restrictions that were placed in the region in particular Auckland from August to early December restricting both corporate and leisure travellers to the hotel.

The hotel’s profitability in the previous and current quarters further demonstrates its viability and capability to off-set the pandemic’s adverse impact on the Company.

Overall operational costs increased mainly from payroll, which is due to the fact there was limited government subsidy during the last six months and increase in minimum wages. Payment made to Ixora Investments Pty Limited (related party) for the purchase of the Hotel (total \$200k) was classified as cash outflows from investing activities.

The administration and corporate costs for the quarter include \$38k in payment of Non-executive Directors fees and Executive Director’s remuneration.

All other head office costs and remaining retail business costs were finalised or were significantly lower compared to previous periods as a result of the exit of the retail subsidiaries from the Group. The exception were one-off final staff termination payments with respect to closure of the retail shops. The Company is now free of all of its leasing commitments, and the administration and corporate expenses have decreased by over \$300k.

Management remains open to once again playing an active role in the “health and well-being” sector in the inbound Chinese tourist retail market as and when the tourism industry returns to some form of normality. With news of anticipated international borders opening, the Company is hopeful that it can return to its core business in the foreseeable future, as it has maintained key stakeholder relationships. In the meantime, the Board and Management

Company is actively exploring other potential revenue generating options to diversify the Company's revenue streams beyond retail and to focus on building shareholder value through business development and growth opportunities for the Group.

The Board and Management are appreciative of the ongoing support of our shareholders during these challenging times.
