

## Swift Signs 3 Year \$3.5 Million Roy Hill Partnership

- Swift has secured a new 3-year partnership agreement with Roy Hill Holdings Pty Ltd ("Roy Hill") to service their world-class Roy Hill Mine Permanent Village (MPV).
- \$3.5 minimum contract value, revenues expected to commence in Q4 FY22.
- This contract represents the largest installation yet of Swift's new engagement, entertainment and communications solution, Swift Access.

Swift today announced it has entered into a new agreement to deploy its proprietary engagement, entertainment, and communication solution to Roy Hill's Mine Permanent Village (MPV). This contract is composed of installation fees in Q4 FY22 and recurring revenues for a minimum of 3 years with two 12-month extension options. The Total Contract Value of the three-year term is from \$3.5 million, increasing with additional room usage and issue of further Call-Off Agreements under the Framework Agreement. This value is based on minimum usage under the issued Call-Off Agreements.

Swift's flagship product, Swift Access will be installed in 2,374 accommodation rooms, 17 executive rooms, and 20 common areas. It will allow workers based at Roy Hill MPV to cast their favourite streaming apps from their mobile device straight to their room's TV, all whilst maintaining user privacy and offering smart device setup and management to improve efficiencies for facility staff. As part of the agreement, Swift will also install a new Village WiFi Network for 2,374 accommodation rooms and 20 common areas.

In addition to casting, Swift Access will provide workers with Swift's full content library including first release movies and sector-specific mental health and indigenous education resources. Swift Access also allows facility managers to easily upload and distribute site information such as inductions, health and safety messages and more, directly to TVs across the site. The entire Swift Access experience is managed by Swift's unique bandwidth management platform and include support services over the term.

Swift CEO Brian Mangano says, "For the past eight years, Roy Hill and Swift have enjoyed a strong partnership based on the mutual values of innovation and high-performance outcomes. This latest collaboration is a natural next step in Swift's mission to assist Roy Hill in providing an outstanding workplace experience. We are excited by a continued Swift, Roy Hill partnership and look forward to working together to create new innovative solutions to the challenges of the FIFO lifestyle."
