This is the second integration by LiveHire to SAP products after the success of the SAP SuccessFactors and LiveHire bi-directional integration. The two integrations help cement LiveHire and SAP products as a leading Total Talent solution for organisations looking to achieve their permanent and contingent hiring goals.

"Candidates today expect a simple and seamless experience when applying for jobs and interacting with potential employers. The LiveHire integration with SAP Fieldglass provides customers with the contingent workforce management solution they need paired with the engagement tools that candidates expect to deliver a best-in-class solution," says Claudio Pinto, Senior Director Partner Ecosystem Success of SAP.

The SAP Fieldglass integration and launch in the SAP<sup>®</sup> Store follows the SAP SuccessFactors integration and launch announced by the Company on 2 June 2020. Under the agreement, SAP will receive a percentage of the net revenue received by LiveHire from customers who integrate the LiveHire platform with their SAP Fieldglass Contingent Management solution (**SAP Customers**). The agreement includes customary termination rights for breach and insolvency, and may be terminated by either party 12 months after an agreed joint communication has been sent to all SAP Customers, or where the LiveHire integration has not yet been purchased by any SAP Fieldglass customers, the agreement may be terminated with 30 days written notice by either party.

#### Significant benefit to LiveHire

The integration of the LiveHire platform with SAP Fieldglass and listing on SAP's APP store, is expected to reduce sale friction and increase brand awareness of our digital direct sourcing platform. The integration allows for a simplified purchasing decision for SAP Fieldglass' customers.

There is no guarantee that any of SAP Fieldglass' clients will sign up to use the LiveHire application as a result of the integration with SAP Fieldglass, however, the integration now opens up a segment of

the market that LiveHire could not previously access without this integration. Accordingly, while the Board consider the SAP Fieldglass integration and launch on the SAP<sup>®</sup> Store to be strategically important for LiveHire, the extent to which any SAP Customers will elect to integrate the LiveHire platform cannot be predicted and as a result the financial impact of the SAP Fieldglass integration and launch on the SAP<sup>®</sup> Store cannot be quantified.

The Company plans to continue to deepen its relationship with SAP Fieldglass and will provide further updates on this sales channel in due course in accordance with its continuous disclosure obligations.
