## ABOUT NELSON RESOURCES

Nelson Resources is an exploration company with a significant and highly prospective 1527km<sup>2</sup> tenure holding (Granted and Pending). The key focus for the Company is its 1220km<sup>2</sup> Woodline Project (Granted and Pending).

The Woodline Project lies on the boundary of the Albany Fraser Oregon and the Norseman - Wiluna Greenstone belt in Western Australia.

### The Woodline Project contains:

- ① 65km of the Cundelee Shear Zone which already consists of a known +20km Gold Geochemical and bedrock anomaly, hosted in the same geological structural setting <sup>2</sup> as the 7.7 million ounce Tropicana Gold mine <sup>3</sup>.
- ① 30km of significantly unexplored greenstones along the Norseman-Wiluna greenstone belt.
