Love Group reports third quarter FY22 results

• Quarterly customer cash receipts of \$862k and net operating cash flow of (\$68k)

- Quarterly customer cash receipts of \$862k, down 12% quarter-on-quarter and up 4% year-on-year
- Ending quarterly cash balance of \$1,298k, a decrease of \$108k quarter-on-quarter as a result of net operating cash flow of (\$68k), net investing cash flow of (\$3k) and FX impact of (\$37k)
- Quarterly expenditure was in line with internal budgets and was focused on the following areas:
 - Advertising and marketing expenditures of \$440K
 - Staff costs including salaries and commissions of \$289K

• Quarterly customer cash receipts by city

- **Hong Kong:** \$550k customer cash receipts for the quarter, versus \$691k in the previous quarter, down 20% quarter-on-quarter, driven by lower consultation volume
- **Singapore:** \$260k customer cash receipts for the quarter, versus \$206k in the previous quarter, up 26% quarter-on-quarter, driven by higher average order value
- **Bangkok:** \$52k customer cash receipts for the quarter, versus \$82k in the previous quarter, down 36% quarter-on-quarter, driven by lower consultation volume
- Growth and expansion strategy
 - o Grow personal matchmaking revenue by increasing new lead and consultation volumes
 - Grow online dating revenue by improving the Lovestruck app experience to convert more free users to paid users via membership subscriptions
 - Selectively expand into new cities using capital efficient and asset light go-to market strategy powered by scalable online marketing channels



Love Group Ltd (ASX:LVE) is pleased to present its quarterly cash flow report and operational update for the quarter ending March 2022.

Love Group Founder and CEO, Michael Ye: "Our cash receipts in the third quarter of fiscal year 2022 was negatively impacted by a substantial drop in cash receipts in our core market of Hong Kong, due to lower consultation volumes as a result of rising COVID cases and new government restrictions put in place. In late April 2022, the Hong Kong government is now gradually easing COVID restrictions, which should help to allow our consultation volumes to rebound."

Cash position

Love Group had a cash position of \$1,298k as at 31 March 2021.

Payments to related parties of the entity and their associates

During the quarter, the Company made payments of \$75k to related parties and their associates, of which \$74k was for director fees and \$1k was for superannuation.
