### Quarterly Activities Report and Appendix 4C for 31 March 2022

- **Hamilton Hotel revenues and occupancy rates increased as restrictions eased in New Zealand**
- **Innlanz is continuously exploring potential opportunities to diversify and grow revenue**

**SYDNEY, AUSTRALIA – 29 April 2022** - Innlanz Limited (ASX: INL) (“Innlanz” or the “Company”), is pleased to provide an update on its quarterly results for the period ended 31 March 2022. A copy of the Appendix 4C - Quarterly Cash Flow Report is attached.

The Company’s total cash position at 31 March was \$1.17m, down by \$590k from the previous quarter.

The Heartland Ambassador Hamilton Hotel finished the quarter with an occupancy level of 73% and ADR (average daily rate) of NZD147.31, which grew approximately by NZD8.00 in comparison to same period previous year. This has assisted the hotel to reach approximately a total revenue of \$1.2m for the 9 months ended 31 March 2022. The result has slightly exceeded the Company’s expectations given the Covid 19 restrictions that were placed in New Zealand in particular Auckland/Hamilton region from August to November 2021 restricting both corporate and leisure travellers to the hotel.

With minimal restrictions during this reporting period, pleasingly the hotel achieved a total income of NZD513K (AUD477K) in this quarter. This demonstrates the hotel’s potential to help off-set the pandemic’s adverse impact on the Company providing restrictions continue to ease. Overall hotel operational costs increased compared to the previous reporting period to allow the hotel to service the demands resulting from the greater occupancy rates.

Payments made to Ixora Investments Pty Limited (related party) for the purchase of the Hotel (total \$300k) were classified as cash outflows from investing activities.

The administration and corporate costs for the quarter include \$38k in payment of Non-executive Directors fees and Managing Director’s remuneration and general administrative related cost including compliance.

Management remains open to once again playing an active role in the “health and well-being” sector in the inbound Chinese tourist retail market as and when the tourism industry returns to some form of normality. With international borders opening, the Company is monitoring this diligently in order to re-opening of its retail stores. In the meantime, the Company’s Board and Management are actively exploring other potential revenue generating options to add to the Company’s current revenue stream and to focus on building shareholder value through business development and growth opportunities for the Group.

The Board and Management are appreciative of the ongoing support of our shareholders during these challenging times.
