\$3.5M Option Financing Agreement as announced 20 April 2021.

Under a funding agreement RiverFort Global Capital Ltd, a London based UK Institutional Investment Manager focusing on high-growth companies, advanced the Company \$3.5 million which will be repaid from the proceeds of deep in the money Options, with the Options due to be exercised on or before 30 June 2022. Under the Funding Agreement Riverfort will be paid interest at a rate of 6% per annum, payable monthly, on the outstanding balance of the \$3.5 million. \$800,000 was repaid during the quarter from options exercised.

Answer: No. Cash outflows will be reduced. A drilling campaign of 204,000 metres is now almost complete. The Company will assess the data from remaining assay results to be received and has reduced the number of drilling rigs from 11 to 5 across the Company's projects in Ecuador and Argentina.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company is continuously assessing funding requirements, expenditure savings and the fund raising options for the Company to continue its exploration activities.

3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes, based on the explanations provided in points 1 and 2 above.
