Appointment of highly experienced lawyer Adrienne Parker to bring strong legal, commercial and corporate experience to the Liontown Board

Liontown Resources Limited (ASX: LTR) is pleased to announce the appointment of Ms Adrienne Parker to its Board as an Independent Non-Executive Director, effective 1 October 2022.

Following commencement, it is envisaged that Ms Parker will also be appointed to one or more of the sub-committees of the Board. Ms Parker will be considered as an Independent Director upon joining the Board.

Liontown Chairman, Tim Goyder, said:

"We are delighted that Adrienne has agreed to join the Liontown Board at an exciting and very important time in the development of the Kathleen Valley Lithium Project. She will bring substantial legal, commercial and business knowledge which will be invaluable as we progress the Project through development and into operation."
