<div style="border: 1px solid black; padding: 5px;"> Answer: No, given the challenging retail trading conditions and significant capital requirements for growing the eCommerce segment of the business, the Board has decided to reposition Design Milk to an advertising revenue only model and shut down the eCommerce operations. This significantly saves overhead costs and reduces cash outflows. </div>

The issue of convertible notes will be put forward for approval at the upcoming AGM scheduled for 30 November 2022. </div>
