Dear Shareholder,

Toys"R"Us ANZ Limited (ASX:TOY) - 2022 Annual General Meeting of Shareholders - 07 December 2022

The Board of Toys"R"Us ANZ Limited (**Company**) is pleased to advise that the Company will hold the Annual General Meeting of Shareholders at 2:00pm (Melbourne time) on Wednesday 7th December 2022 (**AGM**).

The Annual General Meeting (Meeting) will be conducted as a hybrid meeting with the physical meeting at RSM Australia, Boardroom, Level 21, 55 Collins Street, Melbourne, VIC 3000 and the virtual meeting, accessible online. As a valued Shareholder of the Company, you are strongly encouraged to:

- Participate in the AGM and pre-register your attendance in advance of the AGM here: https://us02web.zoom.us/webinar/register/WN 1e4JynCSUy8NgxopTzOGQ; and
- Lodge your completed proxy form with the Company's share registry in accordance with the instructions in the Notice of Meeting. Proxy forms must be received by the share registry by no later than 48 hours before the AGM.

All Resolutions will be decided on a poll. The poll will be conducted based on votes submitted by proxy and at the Meeting by Shareholders who have indicated that they intend to vote at the Meeting in accordance with the instructions set out below

Venue for Virtual Meeting

If you are a Shareholder and wish to virtually attend the Meeting (which will be broadcast as a live webinar) please **pre-register** in advance of the virtual Meeting here:

After registering, you will receive a confirmation containing information on how to attend the virtual Meeting on the day of the AGM.

Venue for physical Meeting

The physical Meeting is at RSM Australia, Boardroom, Level 21, 55 Collins Street, Melbourne, VIC 3000.

How do I ask questions at the 2022 AGM?

Shareholders will be able to vote and ask questions at the virtual Meeting. Shareholders are also encouraged to submit questions in advance of the Meeting to the Company. Questions must be submitted to AGM@toysrus.com.au at least 48 hours before the Meeting.

The Company will also provide Shareholders with an opportunity to ask questions during the Meeting in respect of the formal items of business as well as general questions in relation to the Company and its business.

Voting virtually on the day of the AGM

Shareholders who wish to vote virtually on the day of the AGM will need to log into the Automic website (https://investor.automic.com.au/#/home) with their username and password.

Shareholders who do not have an account with Automic are strongly encouraged to register for an account as soon as possible and well in advance of the Meeting to avoid any delays on the day of the Meeting.

How do I create an account with Automic?

To create an account with Automic, please go to the Automic website https://investor.automic.com.au/#/home, click on 'register' and follow the steps. Shareholders will require their holder number (Securityholder Reference Number (SRN) or Holder Identification Number (HIN)) to create an account with Automic.



I have an account with Automic, what are the next steps?

Shareholders who have an existing account with Automic (Note: with a username and password) are advised to take the following steps to attend and vote virtually on the day of the AGM:

- 1. Log into the Automic website https://investor.automic.com.au/#/home using your username and password.
- 2. **Registration on the day**: If registration for the virtual meeting is open, click on 'Meeting open for registration' and follow the steps.
- 3. **Live voting on the day**: If live voting for the virtual meeting is open, click on 'Meeting open for voting' and follow the steps.

Voting by proxy

Shareholders who wish to participate and vote at the AGM are strongly encouraged to complete and submit their proxies as early as possible. To vote by proxy, please use one of the following methods:

Your Proxy instruction must be received not later than 48 hours before the commencement of the Meeting. Proxy Forms received later than this time will be invalid

The Chair intends to vote all open proxies in favour of all Resolutions, where permitted.

If you have provided an email address and elected to receive electronic communications from the Company's share registry, Automic Registry, you will receive an email with a link to an electronic copy of the Notice of Meeting.
